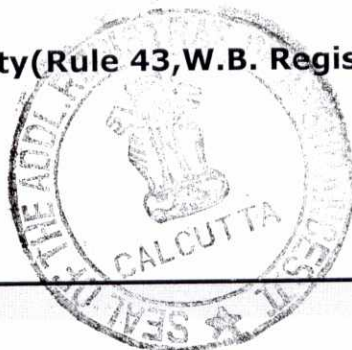

- 5.1.2 **Sale to Vendor:** By a Deed of Sale in Bengali language (*Kobala*) dated 22<sup>nd</sup> June, 1973, registered in the Office of the Sub-Registrar, Cossipore Dum Dum, in Book No.I, Volume No. 98, at Pages 128 to 130, being Deed No. 4822 for the year 1973, Mohammad Rahamatullah sold, conveyed and transferred to the Vendor the entirety of the Mother Property, for the consideration mentioned therein.
