- 3.1 **Sk. Alamgir alias Sekh Alamgir**, son of Late Jammal Ali *alias* Jamat Sekh Ali *alias* Sekh Jammal Ali, residing at Village Raigachi Choumatha, Post Office Rajarhat, PIN 700185, Police Station Rajarhat, District North 24 Parganas (**PAN AIHPA5560E**)

(Vendor, includes successors-in-interest)

And

- 3.2 **Ahnanat Traders Private Limited**, a company incorporated under the Companies Act, 1956, having its registered office at 14, N.S. Road, Kolkata-700001, Police Station Hare Street (**PAN AAGCA4233L**), represented by its authorized signatory **Abinash More**, son of Rajendra Prasad Agarwala, of 18A, Mayfair Road, Kolkata-700019, Police Station Karaya

(Purchaser, includes successors-in-interest).

Vendor and Purchaser are hereinafter individually referred to as such or as **Party** and collectively as **Parties**.

NOW THIS CONVEYANCE WITNESSES AS FOLLOWS:

4. Subject Matter of Conveyance

- 4.1 **Said Property:** Land classified as *sali* (agricultural) measuring 3.5 (three point five) decimal equivalent to 2 (two) *cottah* 1 (one) *chittack* and 39.6 (thirty nine point six) square feet, more or less [out of 56 (fifty six) decimal equivalent to 1 (one) *bigha* 13 (thirteen) *cottah* 14 (fourteen) *chittack* and 3.456 (three point four five six) square feet, more or less], being a portion of R.S./L.R. *Dag* No.651, recorded in L.R. *Khatian* No.499, *Mouza* Raigachi, J.L. No. 12, Police Station Rajarhat, within the jurisdiction of Rajarhat-Bishnupur No. 1 *Gram Panchayet*, Sub-Registration District Rajarhat (formerly Bidhannagar), District North 24 Parganas and more fully described in the **Schedule** below and the said *Dag* No.651 is delineated and demarcated on the **Plan** annexed hereto and bordered in colour **Red** thereon (**Said Property**) together with all title, benefits, easements, authorities, claims, demands, usufructs and tangible and intangible rights of whatsoever or howsoever nature of the Vendor in the Said Property and appurtenances and inheritances for access and user thereof.

5. Background, Representations, Warranties and Covenants

- 5.1 **Representations, Warranties and Covenants Regarding Title:** The Vendor represents and warrants to and covenants with the Purchaser regarding title as follows:

- 5.1.3 **Demise of Lakshmi Khatoon:** Lakshmi Khatoon, one of the Legal Heirs Of Golam Rasul, a Muslim governed by the *Sunni* School of Mohammedan Law, died *intestate* as a spinster, leaving behind her surviving her mother, Chand Bibi and her only brother, Golam Sarawar (collectively **Legal Heirs Of Lakshmi Khatoon**), as her sole legal heiress and heir, who jointly inherited the right, title and interest of Late Lakshmi Khatoon in the Mother Property, each having diverse shares and/or interest therein.
- 5.1.4 **Marriage of Chand Bibi with Golam Kader:** After the death of her first husband, Golam Rasul, Chand Bibi got married for the second time with Golam Kader and out of such wedlock Sheikh Anowar Ali *alias* Sk. Anowar Ali *alias* Sekh Anowar (**Anowar**) was born. The above named Lakshmi Khatoon (one of the Legal Heirs Of Golam Rasul) died prior to the birth of Anowar and hence, in accordance with the *Sunni* School of Mohammedan Law, Anowar got no share and/or interest out of the right, title and interest of Late Lakshmi Khatoon in the Mother Property.
- 5.1.5 **Demise of Golam Kader:** Golam Kader, a Muslim governed by the *Sunni* School of Mohammedan Law, died *intestate*, leaving behind him surviving his only wife, Chand Bibi and his only son, Anowar (collectively **Legal Heirs Of Golam Kader**), as his sole legal heiress and heir, who jointly inherited the right, title and interest of Late Golam Kader in the Mother Property, each having diverse shares and/or interest therein.
- 5.1.6 **Ownership of Chand Bibi In Mother Property:** In the above mentioned circumstances, in accordance with the *Sunni* School of Mohammedan Law, Chand Bibi, being one of the Legal Heirs Of Golam Rasul, one of the Legal Heirs Of Lakshmi Khatoon and also one of the Legal Heirs Of Golam Kader, became the sole owner of land measuring 9.7222 (nine point seven two two two) decimal, more or less, out of the Mother Property.
- 5.1.7 **Mutation:** Though Chand Bibi was entitled for land classified as *sali* (agricultural) measuring 9.7222 (nine point seven two two two) decimal, more or less, out of the Mother Property, she got her name mutated in the records of the Block Land and Land Reforms Office at Rajarhat, in L.R. *Khatian* No.499, in respect of land measuring 5.9528 (five point nine five two eight) decimal, more or less, out of her entitlement in the Mother Property.
- 5.1.8 **Marriage of Chand Bibi with Jammal Ali:** After the death of Golam Kader, Chand Bibi got married for the third time with Jammal Ali *alias* Jamat Sekh Ali *alias* Sekh Jamat Ali and out of such wedlock Sk. Alamgir *alias* Sekh Alamgir (the Vendor herein), being the only son and (1) Kohinoor Begum (2) Mumtaj Begum and (3) Aleya Bibi, being 3 (three) daughters were born.
- 5.1.9 **Said Agreement of Said Property:** By an Agreement dated 2nd November, 2006 (**Said Agreement**), Chand Bibi (the predecessors-in-title of the Vendor) had agreed to sell land classified as *sali* (agricultural) measuring 7 (seven) decimal, more or less (**Portion Of Chand's Entitlement In Mother Property**), out of Chand Bibi's total entitlement in the Mother Property, to Jenco Developers Private Limited (**Jenco**). Jenco paid to Chand Bibi (the predecessors-in-title of the Vendor) a total sum of Rs.40,000/- (Rupees forty thousand) (**Said Advance**) under the Said Agreement.
- 5.1.10 **Gift by Chand Bibi:** By a Deed of Gift in Bengali language (*Daanpatra*) dated 28th January, 2009, registered in the Office of the District Sub-Registrar II, North 24

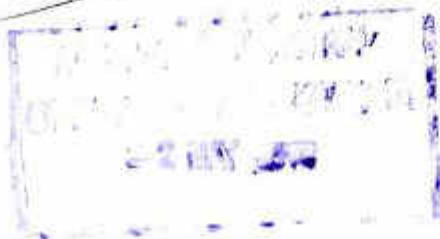

Parganas at Barasat, in Book No. I, CD Volume No.19, at Pages 3367 to 3378, being Deed No.05171 for the year 2013, Chand Bibi, out of her natural love and affection, gifted *inter alia* the entirety of Portion Of Chand's Entitlement In Mother Property to her son, namely Sk. Alamgir *alias* Sekh Alamgir (the Vendor herein) [who was born out of Chand Bibi's wedlock with Jammata Ali *alias* Jamat Sekh Ali *alias* Sekh Jamat Ali (since deceased)].

- 5.1.11 **Absolute Ownership of Vendor in Said Property:** In the above mentioned circumstances, the Vendor has become the sole and absolute owner of the Portion Of Chand's Entitlement In Mother Property. The Said Property (defined in Clause 4.1 above) is a portion of the Portion Of Chand's Entitlement In Mother Property and the Said Property is the subject matter of this Conveyance.
- 5.1.12 **Assignment to Green Oaks:** By an Agreement dated 8th October, 2010 (**First Assignment Agreement**), Jenco assigned to Green Oaks Developers (**Green Oaks**) and its assigns *inter alia* all rights of any and every nature whatsoever of Jenco in the Said Property acquired by virtue of the Said Agreement and/or against Chand Bibi (the predecessors-in-title of the Vendor) under the Said Agreement and/or otherwise together with the benefit of the Said Advance.
- 5.1.13 **Assignment to Siddha Projects:** By an Agreement dated 7th November, 2011 (**Second Assignment Agreement**), Green Oaks further assigned to Siddha Projects Private Limited (**Siddha Projects**) and its assigns *inter alia* all rights of any and every nature whatsoever of Green Oaks in the Said Property acquired by virtue of the Said Agreement, the First Assignment Agreement and/or against Chand Bibi (the predecessors-in-title of the Vendor) under the Said Agreement and the First Assignment Agreement and/or otherwise together with the benefit of the Said Advance.
- 5.1.14 **Assignment to Pioneer Prodev:** By an Agreement dated 31st March, 2012 (**Third Assignment Agreement**), Siddha Projects further assigned to Pioneer Prodev Private Limited (**Pioneer Prodev**) and its assigns *inter alia* all rights of any and every nature whatsoever of Siddha Projects in the Said Property acquired by virtue of the Said Agreement, the First Assignment Agreement, the Second Assignment Agreement and/or against Chand Bibi (the predecessors-in-title of the Vendor) under the Said Agreement, the First Assignment Agreement and the Second Assignment Agreement and/or otherwise together with the benefit of the Said Advance.
- 5.1.15 **Assignment to Purchaser:** By an Agreement dated 3rd March, 2014 (**Fourth Assignment Agreement**), Pioneer Prodev further assigned to the Purchaser and its assigns *inter alia* all rights of any and every nature whatsoever of Pioneer Prodev in the Said Property acquired by virtue of the Said Agreement, the First Assignment Agreement, the Second Assignment Agreement, the Third Assignment Agreement and/or against Chand Bibi (the predecessors-in-title of the Vendor) under the Said Agreement, the First Assignment Agreement, the Second Assignment Agreement and the Third Assignment Agreement and/or otherwise together with all benefits together with the benefit of the Said Advance.

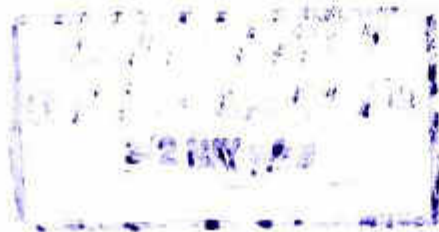

6. Basic Understanding

- 6.1 **Sale of Said Property:** The basic understanding between the Vendor and the Purchaser is that the Vendor shall sell the Said Property to the Purchaser, free from all encumbrances of any and every nature whatsoever and with good, bankable and marketable title and together with *khas*, vacant, peaceful and physical possession and the Purchaser shall purchase the same based on the representations, warranties and covenants mentioned in Clauses 5.1 and 5.2 and their respective sub-clauses above (collectively **Representations**).
- 6.2 **Surrender of Rights by Ms. Vinita Jain:** Ms. Vinita Jain of 99A, Park Street, Kolkata-700016 has agreement and possessory right over the Said Property and the Purchaser agrees to settle all rights/claims of Ms. Vinita Jain at own cost and

responsibility and confirms and assures that the Vendor shall have no responsibility or obligation in this regard.

7. Transfer

7.1 **Hereby Made:** The Vendor hereby sells, conveys and transfers to the Purchaser the entirety of the Vendor's right, title and interest of whatsoever or howsoever nature in the Said Property, more fully described in the **Schedule** below, being classified as *sahi* (agricultural) measuring 3.5 (three point five) decimal equivalent to 2 (two) *cottah* 1 (one) *chittack* and 39.6 (thirty nine point six) square feet, more or less [out of 56 (fifty six) decimal equivalent to 1 (one) *bigha* 13 (thirteen) *cottah* 14 (fourteen) *chittack* and 3.456 (three point four five six) square feet, more or less], being a portion of R.S./L.R. *Dag* No.651, recorded in L.R. *Khatian* No.499, *Mouza* Raigachi, J.L. No. 12, Police Station Rajarhat, within the jurisdiction of Rajarhat-Bishnupur No. I *Gram Panchayet*, Sub-Registration District Rajarhat (formerly Bidhannagar), District North 24 Parganas and the said *Dag* No.651 is delineated and demarcated on the **Plan** annexed hereto and bordered in colour **Red** thereon **together with** all title, benefits, easements, authorities, claims, demands, usufructs and tangible and intangible rights of whatsoever or howsoever nature of the Vendor in the Said Property and appurtenances and inheritances for access and user thereof, free from all encumbrances.

7.2 **Consideration:** The aforesaid transfer is being made in consideration of a sum of Rs.16,30,468/- (Rupees sixteen lac thirty thousand four hundred and sixty eight) paid by the Purchaser to the Vendor, receipt of which the Vendor hereby and by the Receipt and Memo of Consideration hereunder written, admits and acknowledges.

8. Terms of Transfer

8.1 **Salient Terms:** The transfer being effected by this Conveyance is:

8.1.1 **Sale:** a sale within the meaning of the Transfer of Property Act, 1882.

8.1.2 **Absolute:** absolute, irreversible and perpetual.

8.1.3 **Free from Encumbrances:** free from all claims, demands, encumbrances, mortgages, charges, liens, attachments, *lis pendens*, uses, *debutters*, trusts, prohibitions, Income Tax attachments, financial institution charges, statutory prohibitions, acquisitions, requisitions, vesting, *bargadars* and liabilities whatsoever or howsoever made or suffered by the Vendor or any person or persons having or lawfully, rightfully or equitably claiming any estate or interest therein through, under or in trust for the Vendor or the Vendor's predecessors-in-title.

8.1.4 **Together with All Other Appurtenances:** together with all other rights the Vendor has in the Said Property and all other appurtenances including but not limited to customary and other rights of easements for beneficial use of the Said Property.

8.2 **Subject to:** The transfer being effected by this Conveyance is subject to:

8.2.1 **Indemnification by Vendor:** express indemnification by the Vendor about the correctness of the Vendor's title, Vendor's authority to sell and non existence of any encumbrances on the Said Property, which if found defective or untrue at any time, the Vendor shall, at all times hereafter, at the costs, expenses, risk and responsibility of the Vendor, forthwith take all necessary steps to remove and/or rectify. To this effect, the Vendor hereby covenants that the Vendor or any person claiming under the Vendor in

law, trust and equity shall, at all times hereafter, indemnify and keep indemnified the Purchaser and/or the Purchaser's successors-in-interest and assigns, of, from and against any loss, damage, costs, charges and expenses which may be suffered by the Purchaser and/or the Purchaser's successors-in-interest and assigns by reason of any claim made by any third parties with respect to the title of the Vendor provided such claims or demands do not pertain to the period on and from the date of this Conveyance.

- 8.2.2 **Transfer of Property Act:** all obligations and duties of vendor and vendee as provided in the Transfer of Property Act, 1882, save as contracted to the contrary hereunder.
- 8.3 **Delivery of Possession:** The Vendor has handed over *khas*, vacant, peaceful and physical possession of the Said Property to the Purchaser.
- 8.4 **Outgoings:** All statutory revenue, cess, taxes, surcharge, outgoings and levies of or on the Said Property, relating to the period till the date of this Conveyance, whether as yet demanded or not, shall be borne, paid and discharged by the Vendor, with regard to which the Vendor hereby indemnifies and agrees to keep the Purchaser fully and comprehensively saved, harmless and indemnified.
- 8.5 **Holding Possession:** The Vendor hereby covenants that the Purchaser and the Purchaser's successors-in-interest and/or assigns shall and may, from time to time, and at all times hereafter, peacefully and quietly enter into, hold, possess, use and enjoy the Said Property and every part thereof exclusively and receive rents, issues and profits thereof and all other benefits, rights and properties hereby granted, sold, conveyed, transferred, assigned and assured or expressed or intended so to be unto and to the Purchaser, without any lawful eviction, hindrance, interruption, disturbance, claim or demand whatsoever from or by the Vendor or any person or persons lawfully or equitably claiming any right or estate therein from under or in trust from the Vendor and it is further expressly and specifically covenanted, confirmed and declared by the Vendor that notwithstanding contained in any law for the time being in force or enacted later or any custom or practice or other form of equitable right or remedy available to the Vendor, the Vendor shall not at any time in future claim any right of pre-emption, right of passage (whether of men, materials, water and other utilities), right of way, means of access, easement of use or any other right of any nature whatsoever or howsoever over and above the Said Property, even if the balance portion of the *Dag* (from which the Said Property has been carved out) is land-locked and does not have any public or private means of access and the Vendor hereby expressly waives, surrenders and give up each and every one of the aforesaid rights.
- 8.6 **No Objection to Mutation:** The Vendor covenants, confirms and declares that (1) the Purchaser shall be fully entitled to mutate the Purchaser's name in all public and statutory records and the Vendor hereby expressly (a) consents to the same and (b) appoints the Purchaser as the constituted attorney of the Vendor and empowers and authorizes the Purchaser to sign all papers and documents and take all steps whatsoever or howsoever in this regard and (2) the Vendor is fully aware that the Purchaser shall convert the nature of use and classification of the Said Property and the Purchaser shall be fully entitled to do the same in all public and statutory records and the Vendor hereby expressly (a) consents to the same, notwithstanding the nature of use and classification of the balance portion of the *Dag* (from which the Said Property has been carved out) being and remaining the same and (b) appoints the Purchaser as the constituted attorney of the Vendor and empowers and authorizes the Purchaser to sign
