## 5. Background, Representations, Warranties and Covenants

### 5.1 Representations and Warranties Regarding Title: The Vendors have made the following representations and given the following warranties to the Purchaser regarding title:

5.1.1 **Deed of Partition:** By a Deed of Partition in Bengali Language (*Bantan Patra*) dated 19<sup>th</sup> November, 1964, registered in the Office of the Sub-Registrar, Barackpore, in Book No. I, Volume No. 77, at Pages 36 to 49, being Deed No. 5694 for the year 1964, Nilendu Kumar Baishya, Bimalendu Kumar Baishya *alias* Bimal Kumar Baishya, Santosh Kumar Baishya, Birendra Kumar Baishya with other co-owners *inter alia* partitioned in metes and bound their all properties out of which (1) Nilendu Kumar Baishya, Bimalendu Kumar Baishya *alias* Bimal Kumar Baishya, Santosh Kumar Baishya became the joint and absolute owners of land classified as *sali* (agricultural) measuring 97 (ninety seven) decimal [equivalent to 58.6847 (fifty eight point six eight four seven) *cottah*], more or less, out of 162 (one hundred and sixty two) decimal, being the portion of R.S. *Dag* No. 700 (**Nilendu And Ors. Property**) And (2) Birendra Kumar Baishya became the owner of land classified as *danga* (highland) measuring 66 (sixty six) decimal [equivalent to 39.9298 (thirty nine point nine two nine eight) *cottah*], more or less, out of 162 (one hundred and sixty two) decimal, being the portion of R.S. *Dag* No. 700 (**Birendra's Property**). Nilendu And Ors. Property and Birendra's Property (collectively the **Mother Property**). The Said Property is a portion of the Mother Property and is the subject matter of this conveyance.

5.1.2 **Demise of Birendra Kumar Baishya:** On or about 21<sup>st</sup> June, 1972, Birendra Kumar Baishya, a Hindu, governed by the *Dayabhaga* School of Hindu Law, died *intestate*, leaving behind him surviving, his wife, Deb Rani Baishya, his only son, Binoy Baishya (Vendor No. 3.4 hereinabove) and his 2 (two) daughters, namely, Kabita Sen (Vendor No. 3.5 hereinabove) and Ratna Saha (Vendor No. 3.6 hereinabove), as his only legal heir and heiresses, who jointly and in equal shares inherited the right, title and interest of Late Birendra Kumar Baishya in Birendra's Property, free from all encumbrances.

5.1.3 **Demise of Deb Rani Baishya:** On or about 9<sup>th</sup> November, 1997, Deb Rani Baishya, a Hindu, governed by the *Dayabhaga* School of Hindu Law, died *intestate*, leaving behind her surviving, her only son, Binoy Baishya (Vendor No. 3.4 hereinabove) and her 2 (two) daughters, namely, Kabita Sen (Vendor No. 3.5 hereinabove) and Ratna Saha (Vendor No. 3.6 hereinabove), as her only legal heir and heiresses, who jointly and in equal shares inherited the right, title and interest of Late Deb Rani Baishya in Birendra's Property. Thus, Binoy Baishya (Vendor No. 3.4 hereinabove), Kabita Sen (Vendor No. 3.5 hereinabove) and Ratna Saha (Vendor No. 3.6 hereinabove) became the joint owners of Birendra's Property comprised in the Mother Property, free from all encumbrances.

5.1.4 **Demise of Nilendu Kumar Baishya:** On or about 20<sup>th</sup> January, 2005, Nilendu Kumar Baishya, a Hindu bachelor, governed by the *Dayabhaga* School of Hindu Law, died *intestate*, leaving behind him surviving, his 2 (two) brothers, namely, Bimalendu Kumar Baishya *alias* Bimal Kumar Baishya (Vendor No. 3.1 hereinabove) and Santosh Kumar Baishya (Vendor No. 3.2 hereinabove), his only sister, Gouri Baishya (Vendor No. 3.3 hereinabove), his brother's son Binoy Baishya (Vendor No. 3.4 hereinabove) and his brother's 2 (two) daughters, namely, Kabita Sen (Vendor No. 3.5 hereinabove) and Ratna Saha (Vendor No. 3.6 hereinabove), as his only legal heirs and heiresses, who jointly and in equal shares inherited the right, title and interest of share of Late Nilendu Kumar Baishya in Nilendu And Ors. Property. Thus, Bimalendu Kumar Baishya *alias* Bimal Kumar Baishya (Vendor No. 3.1

hereinabove) and Santosh Kumar Baishya (Vendor No. 3.2 hereinabove), Gouri Baishya (Vendor No. 3.3 hereinabove), Binoy Baishya (Vendor No. 3.4 hereinabove), Kabita Sen (Vendor No. 3.5 hereinabove) and Ratna Saha (Vendor No. 3.6 hereinabove) became the joint owners of Nilendu And Ors. Property comprised in the Mother Property, free from all encumbrances.

- 5.1.5 **Absolute Ownership of Vendors:** In the circumstances mentioned above, the Vendors have become the undisputed and absolute owners of the Said Property comprised in the Mother Property, free from all encumbrances.
- 5.2 **Representations, Warranties and Covenants Regarding Encumbrances:** The Vendors represent, warrant and covenant regarding encumbrances as follows:
- 5.2.1 **No Acquisition/Requisition:** The Vendors have not received any notice from any authority for acquisition, requisition or vesting of the Said Property and declare that the Said Property is not affected by any scheme of the *Panchayet* Authority or Government or any Statutory Body.
- 5.2.2 **No Excess Land:** The Vendors do not hold any excess vacant land under the Urban Land (Ceiling and Regulation) Act, 1976 or any excess land under the West Bengal Land Reforms Act, 1955 or the West Bengal Estates Acquisition Act, 1953.
- 5.2.3 **No Encumbrance by Act of Vendors:** The Vendors have not at any time done or executed or knowingly suffered or been party or privy to any act, deed, matter or thing, including grant of right of easement, whereby the Said Property or any part thereof can or may be impeached, encumbered or affected in title.
- 5.2.4 **Right, Power and Authority to Sell:** The Vendors have good right, full power, absolute authority and indefeasible title to grant, sell, convey, transfer, assign and assure the Said Property to the Purchaser.
- 5.2.5 **No Dues:** No tax in respect of the Said Property is due to the local authority and/or any other authority or authorities and no Certificate Case is pending for realization of any dues from the Vendors.
- 5.2.6 **No Right of Pre-emption:** No person or persons whosoever have/had/has any right of pre-emption over and in respect of the Said Property or any part thereof.
- 5.2.7 **No Mortgage:** No mortgage or charge has been created by the Vendors by depositing the title deeds or otherwise over and in respect of the Said Property or any part thereof.
- 5.2.8 **Free From All Encumbrances:** The Said Property is now free from all claims, demands, encumbrances, mortgages, charges, liens, attachments, *lis pendens*, uses, *debuttar*, trusts, prohibitions, Income Tax attachments, financial institution charges, statutory prohibitions, acquisitions, requisitions, vestings, *bargadars* and liabilities whatsoever or howsoever made or suffered by the Vendors or any person or persons having or lawfully, rightfully or equitably claiming any estate or interest therein through, under or in trust for the Vendors or the Vendors' predecessors-in-title and the title of the Vendors to the Said Property is free, clear and marketable.
- 5.2.9 **No Personal Guarantee:** The Said Property is not affected by or subject to any personal guarantee for securing any financial accommodation.

- 5.2.10 **No Bar by Court Order or Statutory Authority:** There is no order of Court or any other statutory authority prohibiting the Vendors from selling, transferring and/or alienating the Said Property or any part thereof.

## 6. Basic Understanding

- 6.1 **Agreement to Sell and Purchase:** The basic understanding between the Parties is that the Vendors will sell the Said Property to the Purchaser free from all encumbrances of any and every nature whatsoever and with good, bankable and marketable title and **together with** *khas*, vacant, peaceful and physical possession and the Purchaser will purchase the same on the representations, warranties and covenants mentioned in Clauses 5.1 and 5.2 and their sub-clauses mentioned above (collectively **Representations**).

- 6.2 **Surrender/Transfer of Rights:** Maa Amba Infrastructure Private Limited having its office at B-401, 4<sup>th</sup> Floor, City Centre, Salt Lake, Kolkata-700064 (**First Company**) had contractual transferable interest and/or right in the Said Property. Suman Construction Company Private Limited, 4, Ratan Sarkar Garden Street, Kolkata - 700007 (**Second Company**) had contracted with the Purchaser to cause the sale of the Said Property to the Purchaser directly from the Vendors and to cause the First Company to surrender all its rights, interests and claims, of any and every nature whatsoever, for a consolidated consideration, which included the price to be paid to the Vendor and the compensation to be paid to the First Company as well as the profit of the Second Company. Pursuant to the above, the Second Company is causing sale of the Said Property by the Vendors directly to the Purchaser by this Conveyance. It is also recorded that by virtue of commercial negotiation and amicable settlement with the First Company, the First Company surrendered all its rights, interests and claims, of any and every nature whatsoever, in favour of the Purchaser for mutually agreed consideration and the Second Company also confirmed that it has released/transferred all its rights in the Said Property to the Purchaser, for mutually agreed consideration.

## 7. Transfer

- 7.1 **Hereby Made:** The Vendors hereby sell, convey and transfer to the Purchaser the entirety of the Vendors' right, title and interest of whatsoever or howsoever nature in the Said Property more fully described in the **Schedule** below, being, Land classified as *sali* (agricultural) measuring 9 (nine) decimal [equivalent to 5.445 (five point four four five) *cottah*], more or less, out of 162 (one hundred and sixty two) decimal, being the portion of R.S. *Dag* No. 700, corresponding L.R. *Dag* No. 1598, recorded in L.R. *Khatian* Nos. 414, 508, 798 349/1 and 497/2, *Mouza* Patulia, J.L. No. 4, Police Station Khardah, within the jurisdiction of PGP, Sub-Registration District Barackpore, District North 24 Parganas, more fully described in the **Schedule** below and the said R.S. *Dag* No. 700 being delineated and demarcated on the **Plan** annexed hereto and bordered in colour **Red** thereon **together with** all title, benefits, easements, authorities, claims, demands, usufructs, tangible and intangible rights of whatsoever or howsoever nature of the Vendors in the Said Property and appurtenances and inheritances for access and user thereof, free from all encumbrances.
- 7.2 **Total Consideration:** The aforesaid transfer is being made in consideration of a sum of Rs.4,48,956/- (Rupees four lac forty eight thousand nine hundred and fifty six) paid by the Purchaser to the Vendors, receipt of which the Vendors hereby as well as by the Vendors' Receipt and Memo of Consideration hereunder written, admit and acknowledge.

## 8. Terms of Transfer

8.1 **Salient Terms:** The transfer being effected by this Conveyance is:

8.1.1 **Sale:** a sale within the meaning of the Transfer of Property Act, 1882.

8.1.2 **Absolute:** absolute, irreversible and perpetual.

8.1.3 **Free from Encumbrances:** free from all claims, demands, encumbrances, mortgages, charges, liens, attachments, lis pendens, uses, *debuttar*, trusts, prohibitions, Income Tax attachments, financial institution charges, statutory prohibitions, acquisitions, requisitions, vestings, *bargadars* and liabilities whatsoever or howsoever made or suffered by the Vendors or any person or persons having or lawfully, rightfully or equitably claiming any estate or interest therein through, under or in trust for the Vendors or the Vendors' predecessors-in-title.

8.1.4 **Together with All Other Appurtenances:** together with all other rights the Vendors have in the Said Property and all other appurtenances including but not limited to customary and other rights of easements for beneficial use of the Said Property.

8.2 **Subject to:** The transfer being effected by this Conveyance is subject to:

9.2.1 **Indemnification:** Indemnification by the Vendors about the correctness of the Vendors' title and authority to sell and this Conveyance is being accepted by the Purchaser on such express indemnification by the Vendors about the correctness of the Vendors' title, which if found defective or untrue at any time, the Vendors shall, at the costs, expenses, risk and responsibility of the Vendors, forthwith take all necessary steps to remove and/or rectify.

9.2.2 **Transfer of Property Act:** All obligations and duties of vendor and vendee as provided in the Transfer of Property Act, 1882, save as contracted to the contrary hereunder.

8.3 **Delivery of Possession:** *Khas*, vacant, peaceful and physical possession of the Said Property have been handed over by the Vendors to the Purchasers.

8.4 **Outgoings:** All statutory revenue, cess, taxes, surcharge, outgoings and levies of or on the Said Property, relating to the period till the date of this Conveyance, whether as yet demanded or not, shall be borne, paid and discharged by the Vendors, with regard to which the Vendors hereby indemnify and agree to keep the Purchasers fully and comprehensively saved, harmless and indemnified.

8.5 **Holding Possession:** The Vendors hereby covenant that the Purchaser and its successors-in-interest and assigns shall and may, from time to time, and at all times hereafter, peacefully and quietly enter into, hold, possess, use and enjoy the Said Property and every part thereof and receive rents, issues and profits thereof and all other benefits, rights and properties hereby granted, sold, conveyed, transferred, assigned and assured or expressed or intended so to be unto and to the Purchaser, without any lawful eviction, hindrance, interruption, disturbance, claim or demand whatsoever from or by the Vendors or any person or persons lawfully or equitably claiming any right or estate therein from under or in trust from the Vendors.





- 8.6 **Indemnity:** The Vendors hereby covenant that the Vendors or any person claiming under the Vendors in law, trust and equity shall, at all times hereafter, indemnify and keep indemnified the Purchaser and/or the Purchaser's successors-in-interest and assigns, of, from and against any loss, damage, costs, charges and expenses which may be suffered by the Purchaser and/or the Purchaser's successors-in-interest and assigns by reason of any encumbrance on the Said Property.
- 8.7 **No Objection to Mutation:** The Vendors declare that the Purchaser shall be fully entitled to mutate the Purchaser's name in all public and statutory records and the Vendors hereby expressly (1) consent to the same and (2) appoint the Purchaser as the constituted attorney of the Vendors and empower and authorize the Purchaser to sign all papers and documents and take all steps whatsoever or howsoever in this regard. Notwithstanding such grant of powers and authorities, the Vendors undertake to co-operate with the Purchaser in all respect for causing mutation of the Said Property in the name of the Purchaser and in this regard shall sign all documents and papers as required by the Purchaser.
- 8.8 **Further Acts:** The Vendors hereby covenant that the Vendors or any person claiming under them, shall and will from time to time and at all times hereafter, upon every request and at the cost of the Purchaser and/or its successors-in-interest and assigns, do and execute or cause to be done and executed all such acts, deeds and things for further or more perfectly assuring the title of the Said Property.

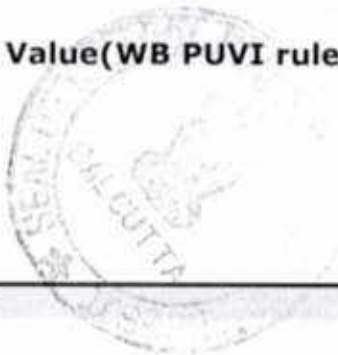
