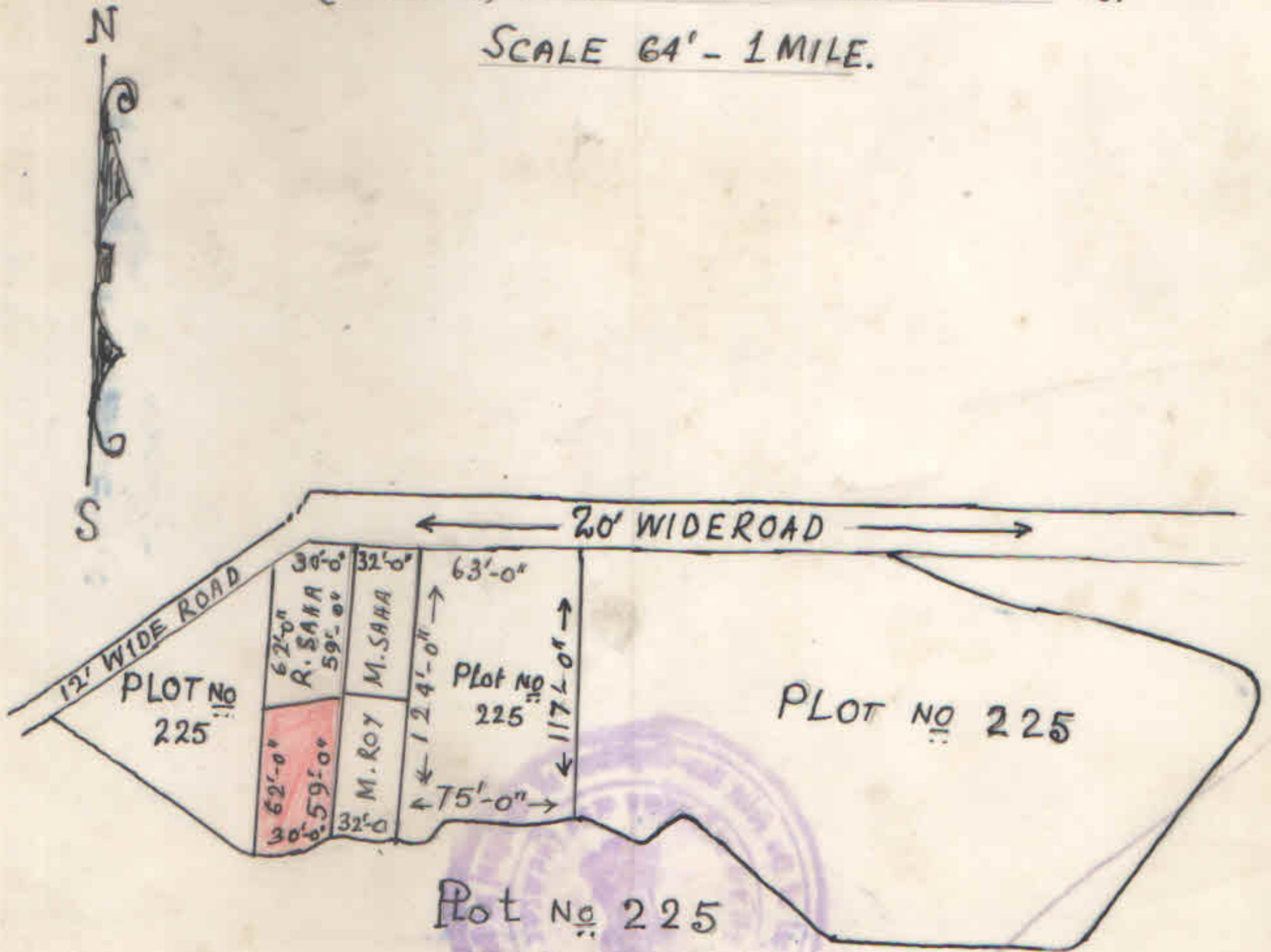

That my nick name is Smt. MANJUSHREE ROY.


