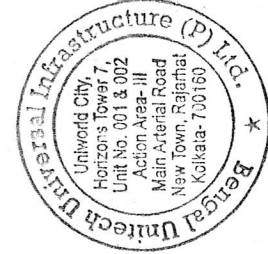

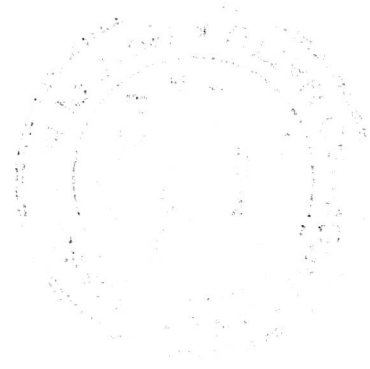

3. That the time period within which the project shall be completed by promoter is 31/12/2024.

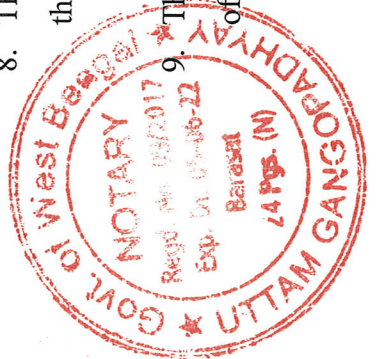
4. That seventy per cent of the amounts realized by the promoter for the real estate
