This SUPPLEMENTARY DEVELOPMENT AGREEMENT is made on this 28th day of May Two Thousand and Eighteen

BETWEEN

M/S. SIMPLEX PROJECT LIMITED (a Company registered under the Companies Act, 1956) having PAN AADCS8598R, represented by Sri Jai kishan Bagri, son of Late Sri Bal Kishan Bagri, having PAN AFRPB3749K, aged about 69 years, Authorise Representative of Simplex Projects Ltd, having its registered office at 12/1, Nellie Sengupta Sarani, Police Station – New Market, Kolkata – 700 087, hereinafter called "OWNER" (which expression shall where the context so admits to include its successors in office, administrators or permitted assigns) of the ONE PART :

AND

SHREE RSH PROJECTS PVT LTD, being PAN-AAOCS3902Q a company having been incorporated under the Companies Act 1956, represented by **Mr. Hari Prasad Sharma**, being PAN-ALQPS4877E Son of Late Sanwarmal Sharma, aged about 48 years, Director of Shree RSH Projects Pvt Ltd, having its registered office situated at 20, O.C. Ganguly Sarani (Lee Road), Kolkata 700020 Police Station **Bhowanipore**, Post office- **LalaLajpat Rai Sarani**.....hereinafter referred to as the "DEVELOPER" (which term or expression shall unless repugnant to the context shall deem to mean and include its successor and/or successors in interest and assigns) of the **OTHER PART** :

WHEREAS:

- A. By a DEVELOPMENT AGREEMENT dated 7th August, 2014 Simplex Projects Limited entered into between Owner and the Developer herein, the aforesaid Development Agreement has been duly registered in the office of the ADSR Alipore South 24 Parganas, in **Book No. I CD Volume No. 27, Pages 1913 to 1938 as being Deed No. 06426 Year 2014 Serial No. 7942/2014** for development of ALL THAT piece and parcel of land measuring 43.04 Cottahs, lying and situated at KIT Scheme No. 118 at premises now known as Block No. 17D, Prince Gulam Md. Shah Road, Kolkata 700045 of the surplus land of KIT morefully described in the First Schedule hereunder written.
- B. As per agreement it was agreed that the Developer will develop the said premises by constructing a multi-storied building thereon and the constructed area will be shared in the ratio of 50:50 between the Developer and the Owner.
- C. In view of the present rough patch/phase of the Real Estate Market scenario around the country it has been mutually agreed by and between the parties to review sharing ratio of the constructed area of the proposed multistoried building being constructed on the said plot.
- D. The Owner and Developer held discussions, negotiations pursuant to which terms and conditions for reconsideration for development of the said property have been finalized.
- E. That this agreement is Supplemental Agreement to the Development Agreement dated 7th August, 2014 made and executed between the existing Owner and Developer.
- G. The Parties are now entering into this Supplemental Agreement to record the terms and conditions agreed by and between themselves.

H. In consideration of the changed scenario of the Development, the Owner shall be entitled to 43.8% of total Super Built Up Area in the Project and balance area 56.2% shall belong to the Developer. The Owner/s Allocation and the Developer/s Allocation shall mean their respective allocations morefully to be described after the casting of the final roof of the proposed building.

I. The Owner will have the right to sale out of their ^{undivided} allocated ratio of 43:8% and will intimate of the same to the Developer.

All other terms and conditions as recorded on the Development Agreement dated 7th August, 2014 remains unchanged and shall run consequently and will be co-existent and co-terminus with this Supplemental Agreement.
