

- 2. That the said land is free from all encumbrances
- That the time period within which the project shall be completed by me/ promoter is 3. July'2021.
- That seventy per cent of the amounts realized by me/promoter for the real estate project from 4. the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- That the amount from the separate account, to cover the cost of the project, shall withdrawn in 5. proportion to the percentage of completion of the project.
