NOW THIS AGREEMENT WITNESSETH and it is hereby agreed by and between the parties hereto as follows:

- Subsequent to execution this Agreement Sri Amlanabha Das will be entitled to the entire 1/15th share of the said Premises of his mother Shefali Das, since deceased subject to grant of probate in his favour.
- Smt. Sulalita Das, Smt. Sharmila Saha and Smt. Jayasree Saha have no objection for grant of probate in favour of their bother Sri Amlanabha Das to own and occupy the entire 1/15th share of the said Premises of their mother Shefali Das, since deceased.
- 3. Smt.
