
Dear Sir(s),

Permission for Construction of drain to be done by Riya Gitanjali through jack push system by crossing the Barrackpur Barasat road at chainage 5.08 KM near Mudibari during the year 2018-19. has been granted by the Executive Engineer, P.W.D. Barrackpur Division after deposition of above referred amount by draft as well as bank guarantee and the permission is subject to the following terms and conditions.

1. For this work only jack push system should be used & no open cut system will be allowed with in the black top carriage way & hard shoulder portion.
2. The proposed work will not interfere with or cause any damages to the existing Water Supply/ Electric/Telephone lines, etc. if any along/across the road stated above.
3. If any trench or hole is excavated by you it shall be duly fenced, properly barricaded and suitable sign boards provided, Red light etc. shall be placed at night at suitable places and all necessary pre-cautions should be taken to guard against any accident.
4. The excavation to be restricted as per submitted drawings.
5. No tree may be cut or trimmed during the execution of work.
6. No part of the structure may encroach upon within 2 mtr. from the black top surface in either side.
7. No part of structure may obstruct smooth flow of traffic.
8. Stability & Safety of structure will have to be certified by an approved structural/ civil engineer and should be up to the entire satisfaction of the Assistant Engineer, PWD Barrackpur Sub Division-III.
9. All damages, direct or indirect, to the road (including flank) shall be temporarily restored without any delay at your own cost and to the entire satisfaction of the concerned Assistant Engineer, P.W.D to avoid accident etc. in the portion worked. This sanction and / or permission for the execution of your proposal has been accorded and / or granted subject to the primary condition that restoration charges in respect of your proposal a leviable under rules have been realized by the concerned Executive Engineer in advance from you.

10. No bridge or culvert which may come across in the process / layout of the pipe/cable line etc. should in any way be disturbed. The proposed line in such portion should wherever possible be diverted so as to avoid the bridge and culvert. Where such diversion is not feasible, specific permission of the undersigned has to be obtained in advance after submission of the detailed drawings showing therein the position and specification of the pipe lines etc. through the particulars bridge/ culvert. All charges including usual deptt. charges required for mending damages to or reconstructing the bridge / culvert or portion thereof, as the undersigned considers necessary should also be paid in advance.
11. You shall shift, alter or remove the pipe/cable line etc. or structures constructed thereupon, if required, for any purpose of the deptt. and as may be called upon by the deptt. to do so. Such shifting, altering or removing and the consequent restoration of damages to the road including its flank shall be done or arranged to be done by you at your own cost in the manner as aforesaid.
12. You shall indemnify Govt. against any loss or damage that may arise, directly or indirectly, beyond, the estimated damages in the course of execution or out of the proposed work.
13. If any defect is subsequently observed in this pipe/cable line etc. (Main or in any of its components), the same should immediately be rectified by you at your own expenses under proper intimation to the undersigned and the result of.
14. No avanus tree should be felled or trimmed except with the specific permission of the appropriate authority having the power to accord the same
15. The proposal/work shall be commenced with reasonable notice being given by you to the Assistant Engineer, P.W.D, Barrackpore Sub-Division-III, Latbagan, Barrackpore, Dist-24 Parganas (N) under Registered Post (Acknowledgement Due), copy of such notice should be sent to the undersigned in the same manner. Work programme should be submitted prior to taking up the work as P.W.D. is to plan for permanent restoration accordingly.
16. While executing your proposal aforesaid you should take care that no spoils of the excavation etc. be thrown into the nearby Nikashi drain and either the same are removed from the site and disposed of as per Municipal Laws or dressed properly so as to allow free drainage of rainwater from the road.
17. Kindly note that this sanction/Permission as being accorded in your favour has been made subject to the terms and condition as stated herein above and this permission and/or sanction of your proposal shall be considered to be valid for a period of 4 (four) months, since the date of issue of this memo.
18. Kindly note that in case of any kind of infringement by you upto any of the terms and conditions stated herein above the permission /sanction as has been accorded herein may stand cancelled thereof after you may be regarded to trespasser upon the Govt. road side land and in that circumstances, you shall not be allowed to proceed further with the work related to your proposal and further actions as per law may be taken against you.
19. Kindly note further that in the event of such happening of infringement upon any of the terms and conditions as stated herein above, the amount of restoration charges if any deposited in favour of the undersigned may be forfeited instantly without assigning any reason what-so-ever to you.
