Khatian nos.-37, 42-47,149, L.R. Dag no.-187, L.R. Khatian no.- 1449, 1450, Holding no. 320, Ward no. 16, under Burdwan Municipality, P.S. & Dist- Burdwan, W.B. by M/s Abhilasha Heights Pvt. Ltd & Aarti Highrise Pvt. Ltd. is within 4.8 Kms. distance from the nearest boundary of Ramnabagan Wildlife Sanctuary and 13.70 Km. distance from adjoining Reserve Forest (Mirjapur R.F) by road.

(2) The Proposed location is not close to the proposed Eco-sensitive zone of Ramnabagan Wildlife Sanctuary.

(3) The Proposed project is for a multi storied residential complex with commercial blocks.

Hence, there may not be any impact on Ramnabagan Wildlife Sanctuary as well as Reserve Forest of Mirjapur in the proposed Project purely for residential use.


