Your site is located at a distance 10916 mts from ARP and lies in the grid G26 of the published CCZM of Kolkata airport. The Permitted top elevation for this grid is 55 mts.

Since the requested top elevation 51 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.
