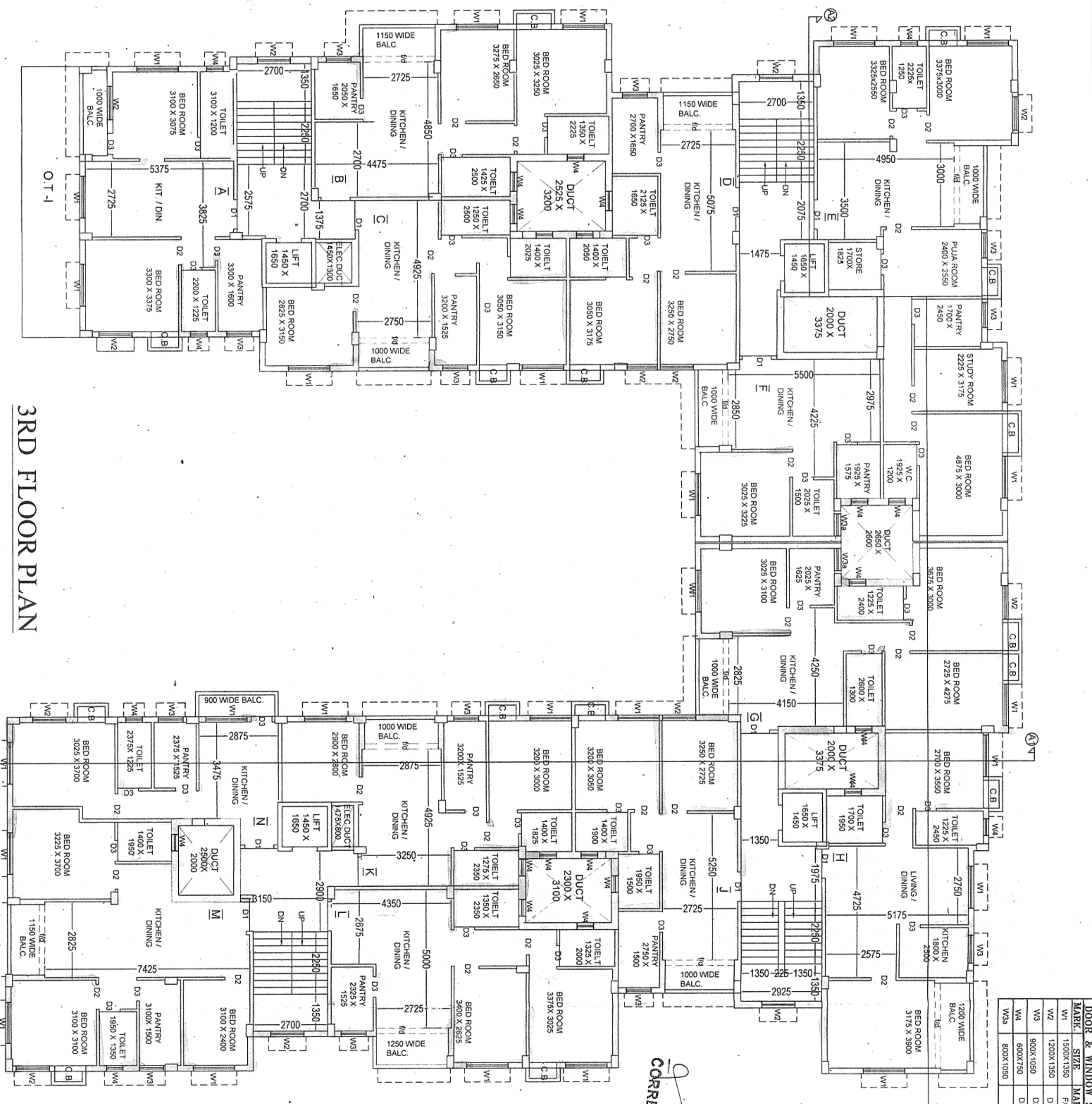
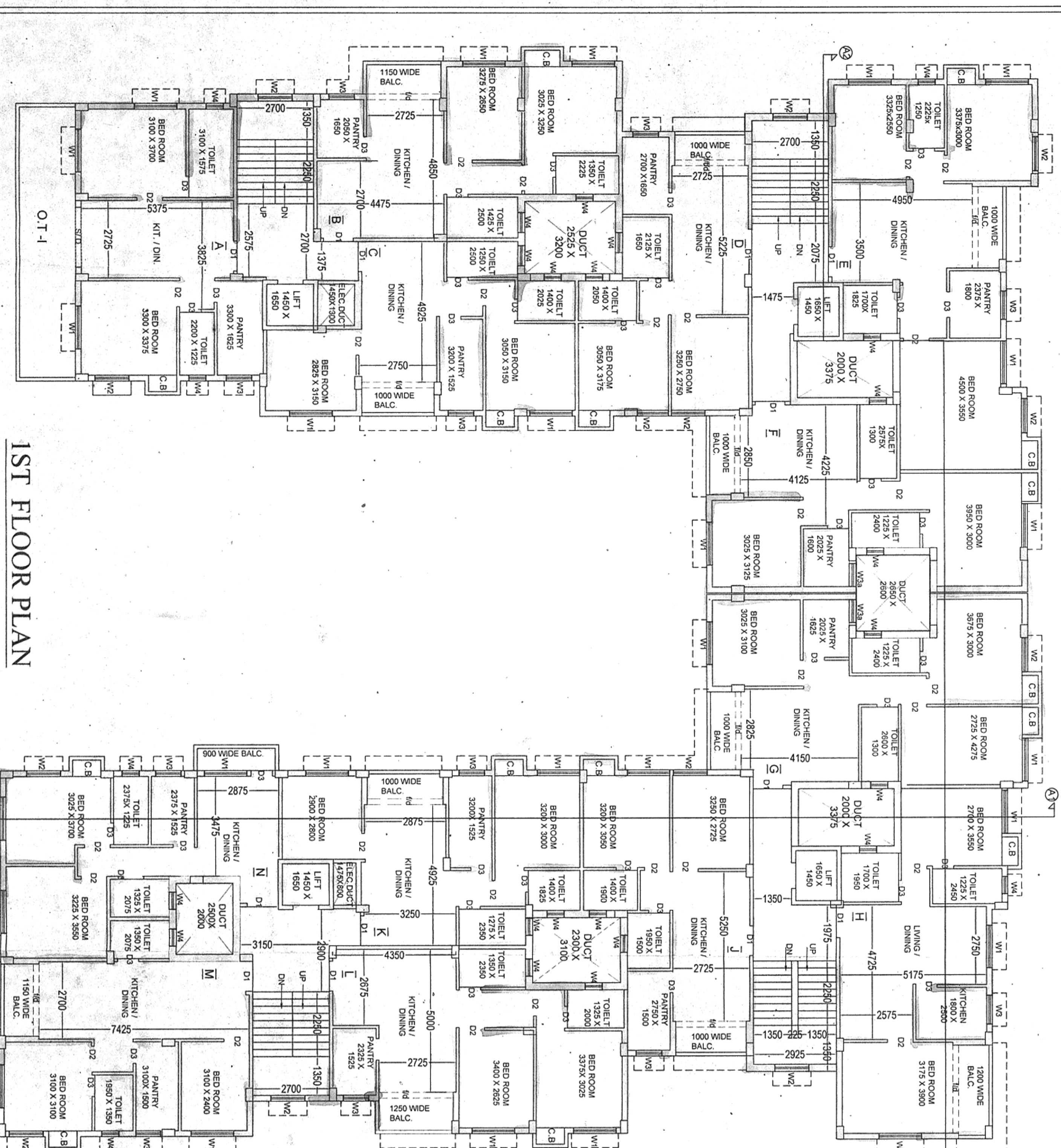


4TH FLOOR PLAN

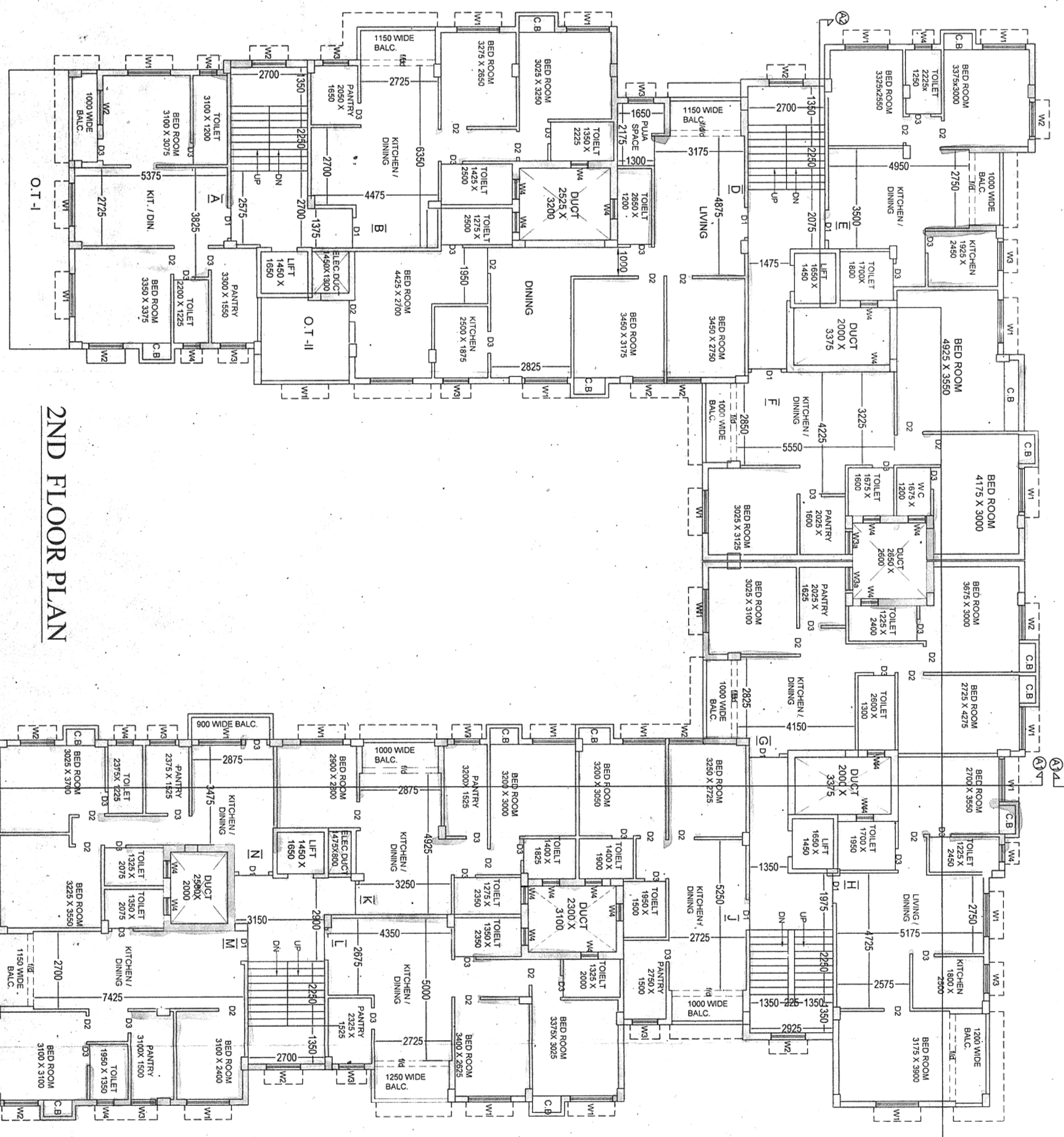
