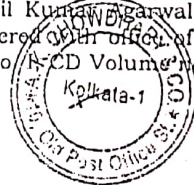

And whereas by an Order dated 27.05.1964 passed by Hon'ble High Court at Calcutta in Insolvency Jurisdiction, said Dharam Chand Dhiman was declared as insolvent on the petition of creditor and the said Dharam Chand Dhiman filed his schedule of affairs before the Hon'ble High Court at Calcutta and all the assets of said Dharam Chand Dhiman including his 1/4th share of Premises 113 and 115, Benaras Road were vested in official Assignee.

And whereas Prem Dhiman died intestate on 03.05.1998 leaving behind Jeeti Dhiman as his legal heir, successor and representative.

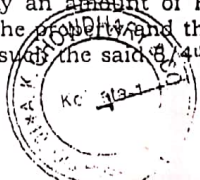

And whereas Kulwant Rai Dhiman died intestate on 26.06.1997 leaving behind Geetanjali Dhiman, Vishal Dhiman as his legal heirs, successors and representatives.

And whereas in course of time different legal proceeding were instituted.

And whereas by an Order dated 15.03.2010 and further order dated 07.04.2010 in C.A. no. 51/2010, 52/2010 and C.A. no. 683/2008 connected with C.P. no. 2/1965 Hon'ble High Court at Calcutta directed to pay an amount of Rs. 62 Lacs to the official liquidator for releasing the said 3/4th share of the property and the entire amount of Rs. 62 Lacs has been paid to the official liquidator. As such the said 3/4th share of the said properties at Premises



no. 113 & 115, Benaras Road stood released unto and in favour of legal heirs of Meher Chand Dhiman, Keher Chand Dhiman, Kishan Chand Dhiman.

And whereas said Gurudev Dhiman sold, transferred and conveyed all that his undivided 1/4th share upon the said Premises nos. 113 & 115, Benaras Road unto and in favour of Arun Kumar Agarwal, Rajesh Agarwal, Sushil Kumar Agarwal, Neelam Agarwal partners of Shree Balaji Construction by a Sale Deed dated 22.07.2010 and the same was duly registered with office of Additional District Sub Registrar at Howrah and recorded in Book no. I, CD Volume no. 18, Pages no. 514 to 540, Being no. 3969 for the year 2010.

And whereas Madan Lal Dhiman sold, transferred and conveyed all that his undivided 1/8th share out of the premises nos. 113 & 115, Benaras Road unto and in favour of Arun Kumar Agarwal, Rajesh Agarwal, Sushil Kumar Agarwal, Neelam Agarwal partners of Shree Balaji Construction by a Sale Deed dated 12.11.2010 and the same was duly registered with office of Additional District Sub Registrar at Howrah and recorded in Book no. I, CD Volume no. 26, Pages no. 2017 to 2045, Being no. 5858 for the year 2010.

And whereas Jeeti Dhiman sold, transferred and conveyed all that her undivided 1/8th share out of the Premises no. 113 & 115, Benaras Road unto and in favour of Arun Kumar Agarwal, Rajesh Agarwal, Sushil Kumar Agarwal, Neelam Agarwal being the partners of Shree Balaji Construction by a Sale Deed dated 27.07.2010 and the same was duly registered with office of Additional District Sub Registrar at Howrah and recorded in Book no. I, CD Volume no. 18, Pages no. 1937 to 1964, Being no. 4030 for the year 2010.

And whereas said Balwant Rai Dhiman, Chaman Kaur alias Sushma Dhiman, Geetanjali Dhiman, Vishal Dhiman, Jyotika Dhiman, Abhinandan Rai Dhiman sold, transferred and conveyed their undivided 1/4th share of land at the said Premises no. 113 and 115, Benaras Road unto and in favour of Arun Kumar Agarwal, Rajesh Agarwal, Sushil Kumar Agarwal, Neelam Agarwal being the partners of Shree Balaji Construction by way of a Sale Deed dated 27.07.2010 and the same was duly registered with office of Additional District Sub Registrar at Howrah and recorded in Book no. I, CD Volume no. 18, Pages no. 1965 to 1993, Being no. 4029.

And whereas said Arun Kumar Agarwal, Rajesh Agarwal, Sushil Kumar Agarwal, Neelam Agarwal amalgamated the said two Premises into one single Premises being no. 113, Benaras Road.

And whereas said Arun Kumar Agarwal, Rajesh Agarwal, Sushil Kumar Agarwal, Neelam Agarwal became the owners of the said land total admeasuring 2 Bighas, 13 Chittacks, 8 Chittacks and 1 Sq. ft. more or less.

And whereas being the partners of Shree Balaji Construction said Arun Kumar Agarwal, Rajesh Agarwal, Sushil Kumar Agarwal, Neelam Agarwal developed the said land and constructed multi storied building upon the said land.


VII. SEARCHES CONDUCTED :




