2. That details of encumbrances on the land including details of any rights, title, interest or name of any party in or over such land, along with details.

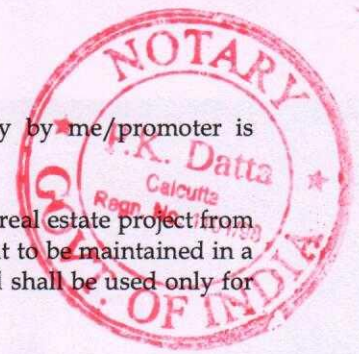

3. That the time period within which the project shall be completely by me/promoter is 30.09.2020.
4. That seventy per cent of the amounts realised by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
6.
