



The Municipal Councillors hereby grant unto **Asim Bose Roy, Anindya Das & Kingshuk Das** Prop / Partner of **Annapurna Nirman**, this licence under section 201 of The West Bengal Municipal Act, 1993, for the use of or part of the premises / Holding No. **13/12/A/44**, **Khardah Station Road**, for the purpose of storing/processing etc. of articles **Promoter, Developer & Constructor** subject to terms and conditions noted below and acknowledge to have received the consideration thereof the sum of **Rs.5000.00 (Five thousand Rupees Only)** only being the licence fee and interest, if any, due for the year/half-year holding for the period **2020-2021**

Terms and conditions

1. That the provision of the WB. Municipal Act, or any other law for the time being in force governing purpose of fire fighting and safety, prevention of pollution, Cruelty to animals, preservation of moments of archeological importance and like as necessary to serve the best interest of public convenience whichever and wherever applicable shall be followed
2. That the premises shall not cause or maintained in a manner likely to cause injury, danger, or offence to the sense of sight smell or hearing of persons residing in the neighbourhood and that they shall not cause or be maintained in a manner so as to cause any danger to life or injury to health of persons employed in the business or residing in the neighbourhood or injury to property or in any other way cause or be maintained in a manner so as to cause inconvenience to the public.

5. That it only relates to such trade as it is specified in it.
6. That no alteration be made in the area of the land or in the building to which the licence relates.
7. That the licence shall not store any place so because any article like petroleum product, any inflammable oil or spirit, any article of combustile nature etc. In excess of the quantity prescribed under Indian Petroleum Act, 1989 and shall take all precautionary measures to safegaurd against any incidence of fire.
