01. NOW BOTH THE PARTIES do hereby agree to allow extension of time on mutual consent without hampering the interest of any party partially amending and or modifying clause 12 at Page No. 05 of the Development Agreement dt. 24th day of August, 2010 which shall now be revised as follows:-

THE COMPANY shall complete the Proposed complex and implement the scheme fully including submission of Completion Certificate from the Competent Authority within 5 (Five) Years from the date of execution of this Agreement subject to force majeure and other reasons beyond the direct control of the COMPANY. Provided however that in case thereby any unsold unit and or portion out of the "said Lands" and or in the proposed Complex of the end of the said period and or it's extension, then and in such event, the conveyance of such units and or portion may be postponed till such time as may be reasonable required.

02. THAT save and except the clause No. 12 as mentioned the other parts of the Development Agreement executed on 24th day of August, 2010 shall remain unchanged and in full force along with this partial amendment/ modification.

03. That this Agreement For Extension Of Time shall be treated as part and parcel of the Development Agreement executed on 24th day of August, 2010.
