- c) That the petitioners will have no claim over the said land if in future the land(s) vest in Stat in any proceeding under any provision of law and shall be liable to be evicted from the said land as trespasser and also shall be liable to payment of damage for the use and occupation of the said land.
- d) That where the land is situated within any urban agglomeration within the meaning of the Urban Land (Celling and Regulation) Act. 1976. the order directing change, conversion or alternation is without prejudice to the provision of the said Act.
