The promoter shall hand over the occupancy certificate of the apartment / plot, as the case may be, to the Allottee at the time of conveyance of the same.

7.2 Failure of Allottee to take Possession of Apartment

Vi) Upon receiving a written intimation from the Promoter as per Para 7.2, the Allottee shall take possession of the Apartment from the Promoter by executing necessary indemnities, undertakings and such other documentation as prescribed in this Agreement and the Promoter shall give possession of the Apartment to the Allottee.
