- 2. That the said land is free from all encumbrances.
- That the time period within which the project shall be completed by us is December 2022.
- 4. That seventy per cent of the amounts realized by the Company for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a schedule bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
