No.2, being Municipal Holding No.34 in Ward No.19, within the Municipal limits of the North Barrackpore Municipality, P.O. & P.S. Barrackpore, District North 24-Parganas, Kolkata 700120, ("the said premises").

As per instructions, I have caused specific searches at the following offices in respect of the aforesaid Dags in the month of September and October 2010:

- (i) Gift Deed dated 20<sup>th</sup> December 2006 made between NemaI Chand Chattopadhyay as the Donor and Barindra Nath Chattopadhyay as the Donee and

registered with the Additional Registrar of Assurances-II, Kolkata in Book No.1 Volume No.1 Pages 1 to 24 Being No.5444 for the year 2007;

(ii) Deed of Rectification / Declaration dated 10<sup>th</sup> August 2007 and registered with the Additional Registrar of Assurances-II, Kolkata in Book No.1 Volume No.1 Pages 1 to 8 Being No.6992 for the year 2007;

For the purpose of ascertaining the title of the Present Owner namely Barindra Nath Chattopadhyay various representations were made and photocopies of certain documents were produced before me, which documents are specifically mentioned in paragraph 1 (Title) hereinbelow:

**1. TITLE:** Based on and after considering the photocopies of the documents of title produced, the representations made, as also the searches caused by me at the abovenamed registration offices, the present position as regards the title of the Present Owner to the said Property is recited hereinbelow:

- A. One Nagendra Nath Chattopadhyay was seized and possessed of and/or otherwise well and sufficiently entitled as the sole and absolute owner to several pieces and parcels of land and properties at different Mouza under different Police Station of different Districts.
- B. The said Nagendra Nath Chattopadhyay who was a Hindu during his life time and also at the time of his death governed by the Dayabhaga School of Hindu Law, died intestate on 25<sup>th</sup> day of Agrahayan 1355 according to the Bengali Calendar (i.e. 12<sup>th</sup> December 1948), leaving him surviving his two sons namely, Kamala Kanta Chattopadhyay and Shib Kanta Chattopadhyay as his only heirs and legal representatives as per Hindu Succession Act and by virtue of inheritance each of the said heirs and legal representatives of the said deceased Nagendra Nath Chattopadhyay, jointly inherited undivided and undemarcated 1/2<sup>nd</sup> (one-half) shares each in the properties left by said deceased Nagendra Nath Chattopadhyay.
- C. During their joint possession said Kamala Kanta Chattopadhyay and Shib Kanta Chattopadhyay had agreed to divide the properties left by their father the said Nagendra Nath Chattopadhyay, deceased, as some difference of opinion had taken place regarding the management of the same and also to avoid any kinds of future litigations. Accordingly they had decided to execute a Partition Deed in connection therewith.
- D. Consequently the said Kamala Kanta Chattopadhyay was allotted several properties, including **ALL THAT** the pieces and parcels of contiguous land forming one single parcel of land, containing an aggregate area of **5.90 Acres** (i.e. 590 sataks / decimals equivalent to 17 Bighas 16 Cottahs 15 Chittacks 9 Square Feet or 356.95 Cottahs) more or less situate lying at and comprised in **L.R. & R.S. Dag No.46/997 (Full 16 annas), L.R. & R.S. Dag No.38/1681 (8 annas), L.R. & R.S. Dag No.38/1680 (Full 16 annas), L.R. & R.S. Dag No.46 (Full 16 annas) and L.R. & R.S. Dag No.46/1682 (8 annas)**, recorded in **L.R.Khatian No.3401** [formerly recorded in L.R.Khatian Nos.3401 and 3358 and prior thereto in R.S.Khatian Nos.915 and 841], Touzi No.2998, Revenue Survey No.38, in Mouza Monirampur, J.L. No.2, being Municipal Holding No.34 in Ward No.19, within the Municipal limits of the North Barrackpore Municipality, P.O. & P.S. Barrackpore, District North 24-Parganas, Kolkata 700120, ADSR Barrackpore, (hereinafter for the sake of brevity referred to as "**the said Premises**"), absolutely and forever, under and by virtue of the Partition Deed dated 16<sup>th</sup> February, 1951, which was registered at District Registry office, Barasat in Book No.1 Volume No.34 Pages 1 to 182 Being No.1345 for the year 1951.

During his possession and enjoyment of the said Premises, Revisional Settlement Survey came into operation and said Kamala Kanta Chattopadhyay had got his name mutated in the R.S.Record of Rights regarding the same, with lands comprised in R.S. Dag Nos.46/997, 38/1681, 38/1680 and 46 recorded as 'Khal' and land comprised in R.S. Dag No.46/1682 recorded as 'Khal'.

F. The said Kamala Kanta Chattopadhyay, who was a Hindu during his lifetime and also at the time of his death governed by the Dayabhaga School of Hindu Law, died on 14<sup>th</sup> day of August 1972, after making and publishing his Last Will and Testament dated 26<sup>th</sup> June 1972 which was registered in the office of Sub-Registry Office Barrackpore in Book No.III Being No.19 for the year 1972. At the time of his death, the heirs in intestacy of the said Kamala Kanta Chattopadhyay were his sole widow namely Smt. Sushama Devi, his four sons namely, Rabindra Nath Chatterjee, Bimalendu Chatterjee, NemaI Chand Chatterjee and Barindra Nath Chatterjee, and his five daughters namely, Smt. Durga Rani Ganguly, Smt. Chandana Mukherjee, Smt. Jyotsna Ghatak, Smt. Shuvra Banerjee and Smt. Bela Banerjee.

G. The said heirs in intestacy of the said Late Kamala Kanta Chattopadhyay did not file any application before the Court to obtain Probate of that said Last Will and Testament dated 26<sup>th</sup> June 1972, rather they agreed to divide and partition the properties left behind by the said Kamala Kanta Chattopadhyay amongst themselves and decided not to go to the Court against each other in future in relation to such partition.

H. Accordingly, under and by virtue of the Partition Deed dated 18<sup>th</sup> September 1976 made between Bimalendu Chatterjee, NemaI Chand Chatterjee and Barindra Nath Chatterjee, therein described as the party of the first part, Rabindra Nath Chatterjee, therein described as the party of the Second Part and Smt. Sushama Devi, therein described as the Party of the third part and Smt. Durga Rani Ganguly, Smt. Chandana Mukherjee, Smt. Jyotsna Ghatak, Smt. Shuvra Banerjee and Smt. Bela Banerjee therein described as the Confirming Parties of the fourth part and registered at Sub-Registry Office, Barrackpore in Book No. I Volume No.68 Pages 6 to 23, Being No.3777 for the year 1976, the said Bimalendu Chatterjee, NemaI Chand Chatterjee & Barindra Nath Chatterjee were allotted and became the joint owners *inter alia* of the said Premises, described in Lot No.2 of the 'Kha' Schedule of the said Partition Deed, absolutely and forever. The Confirming Parties therein confirmed that they had no claim whatsoever in respect of the said Premises partitioned by virtue of the said Partition Deed.

I. During their joint possession, some difference of opinion had arisen regarding the management of the said Premises among the said Bimalendu Chatterjee, NemaI Chand Chatterjee and Barindra Nath Chatterjee. As a result, they agreed to divide and partition the aforesaid property, and to avoid any kind of future litigations, they decided to execute a Partition Deed between them.

J. Accordingly, under and by virtue of the Partition Deed dated 21<sup>st</sup> October 1978 made between the said Bimalendu Chattopadhyaya therein described as the first party and the said NemaI Chand Chattopadhyaya and Sri Barindra Nath Chattopadhyaya therein described as the Second Party and registered in Sub-Registry Office, Barrackpore and recorded in Book No.I Volume No.76 Pages 192 to 200 Being No.4197 for the year 1978, the said NemaI Chand Chattopadhyaya and Barindra Nath Chattopadhyay were allotted and became the joint owners *inter alia* of the said Premises, described in Lot No.2 of the Schedule "A" of the said Partition Deed, absolutely and forever.

K. By a Deed of Gift dated 20<sup>th</sup> December 2006 made between the said NemaI Chand Chattopadhyay (therein mentioned as NemaI Chattopadhyay) therein

referred to as the Donor and the said Barindra Nath Chattopadhyay therein referred to as the Donee and registered with the Additional Registrar of Assurances-II, Kolkata in Book No.1 Volume No.1 Pages 1 to 24 Being No.5444 for the year 2007, as rectified by the Deed of Rectification / Declaration dated 10<sup>th</sup> August 2007 and registered with the Additional Registrar of Assurances-II, Kolkata in Book No.1 Volume No.1 Pages 1 to 8 Being No.6992 for the year 2007, the said Sri Nemai Chand Chattopadhyay in consideration of the natural love and affection towards the said Sri Barindra Nath Chattopadhyay, being his brother, out of his own free will and volition, freely and voluntarily granted conveyed transferred delivered assigned and assured unto and to the said Barindra Nath Chattopadhyay, as and by way of Gift, **All That** his 1/2<sup>nd</sup> (one-half) undivided share in the said Premises, absolutely and forever. In the Gift deed dated 20<sup>th</sup> December, 2006, it appears that inadvertently there has been some typographical error in the description of the property i.e. R.S. Dag No.46/997 has been wrongly typed as R.S. Dag No.38/997 at one place, but correctly stated in the Schedule thereto.

L. The name of Barindra Nath Chattopadhyay is recorded as the owner / raiyat of the said Premises in the Records of Rights of the Government of West Bengal. The mutation formalities in respect of the said Premises have been completed pursuant to the Order & Judgement dated 16<sup>th</sup> August 2001 passed by the Hon'ble West Bengal Land Reforms And Tenancy Tribunal in O.A. No.994 of 2000 (alongwith O.A.Nos.995,996 & 997 of 2000).

M. The said Barindra Nath Chattopadhyay made prayer before the Collector, District Land & Land Reform officer, North 24 Parganas for change of character/classification of the land comprised in the said Premises under Section 4C of the West Bengal Land Reforms, 1955 and the same was recorded as Conversion Case No.13/2008 at Barakpur-1. By a Memo No.Conv.(G)-10/09/3999/1 & LR(N) dated 9<sup>th</sup> September 2009 from the Collector u/s 4C of the W.B.L.R. Act, 1955 Additional District Magistrate and District Land & Land Reform Officer, North 24 Parganas to the said Barindra Nath Chattopadhyay, the change in Classification of the said Premises was allowed and converted into 'Danga'.

1.1 It may be noted that while causing to be made searches, relevant Index at the said registration offices for certain years were found to be incomplete or torn or partly torn or damaged or not available or transfer volumes not available or not indexed and therefore searches for those years could not be made. Further, it may be noted that certain documents, registration of which have not been completed and have been provisionally registered and/or kept pending and/or in abeyance by the concerned registration offices, are not noted in the Index, and such searches in respect those documents cannot be nor have been made. Full details of the Index which were found to be incomplete or torn or partly torn or damaged or not available or not indexed are ascertainable from the reports of searches caused which are annexed hereto in original alongwith the respective original search receipts as hereinbelow mentioned:

Original Receipt, bearing No. REGN. R - 294819 dated 24<sup>th</sup> September 2010, for Index II searching issued by the Office of Registrar of Assurances, Kolkata is annexed hereto (with original report of searches caused by Ms.Haasi Datta) and marked as "A-1".

Original Receipt, bearing No. REGN Q- 974557 dated 24<sup>th</sup> September 2010 for Index II issued by the Additional District Sub-Registrar, Barrackpore records for searches at District Registrar, Barasat and Sub-Registrar, Barrackpore (with original report of searches caused by Ms.Haasi Datta) and marked as "A-2".

Original Receipts, bearing Nos. REGN R - 294686 dated 1<sup>st</sup> October 2010 and REGN R - 294685 dated 1<sup>st</sup> October 2010 for Index I searching both issued by the office of the Registrar of Assurances, Kolkata are annexed hereto (with original report of searches caused by Haasi Datta) and collectively marked as "A-3".

Original Receipt, bearing No. REGN Q - 917818 dated 30<sup>th</sup> September 2010 for Index I searching issued by the Additional District Sub-Registrar, Barrackpore records for searches at District Registrar, Barasat and Sub-Registrar, Barrackpore (with original report of searches caused by Ms.Haasi Datta) and marked "A-4".

**B. ACQUISITION AND REQUISITION SEARCHES AT THE LAND ACQUISITION COLLECTOR, BARASAT:**

As informed to my representative it appears that the aforesaid L.R & R.S. Dag Nos.46/997, 38/1681, 38/1680, 46 and 46/1682, recorded in L.R.Khatian No.3401 in Mouza Monirampur, J.L. No.2, being Municipal Holding No.34 in Ward No.19, within the Municipal limits of the North Barrackpore Municipality, P.O. & P.S. Barrackpore, District North 24-Parganas, Kolkata 700120 is at present not affected by any acquisition or requisition proceedings at the Office of The Land Acquisition Collector, Barasat. However, no certificate from the Land Acquisition Collector, Barasat, has been received nor are they issuing any certificates and as such my search at the Land Acquisition Collector, Kolkata is based on the information received on verbal inquiries made by my representative.

**C. CIVIL COURT:**


(a) From the eight certificates issued by the Court of the 4<sup>th</sup> Civil Judge (Junior Division) at Sealdah, all dated 28<sup>th</sup> September 2010, no Title Suit or Title Execution and/or Money Suit or Money Execution Case appears to have been filed in the said Court by or against (i) **Nemai Chand Chatterjee** (alias Nemai Chattopadhyay) son of Late Kamala Kanta Chattopadhyay for the year 1999 to 2010 and (ii) **Barindra Nath Chattopadhyay** son of Late Kamala Kanta Chattopadhyay for the year 1999 to 2010 (i.e. till the time of my causing searches).

(b) Further, from the eight certificates issued by the Court of the 1<sup>st</sup> Civil Judge (Senior Division) at Barasat, all dated 29<sup>th</sup> September 2010, no Title Suit or Title Execution and/or Money Suit or Money Execution Case appears to have been filed in the said Court by or against (i) **Nemai Chand Chatterjee** (alias Nemai Chattopadhyay) son of Late Kamala Kanta Chattopadhyay for the year 1999 to 2010 and (ii) **Barindra Nath Chattopadhyay** son of Late Kamala Kanta Chattopadhyay for the year 1999 to 2010 (i.e. till the time of my causing searches).

Originals of all the aforesaid sixteen certificates issued by the respective court officers of the abovementioned courts are annexed hereto and marked "B-1 to B-16".

**D. MUNICIPALITY:**

The name of Barindra Nath Chattopadhyay appears to be recorded as the "Present Recorded Owner" in respect of the aforesaid Premises in the records of the said North Barrackpore Municipality.



**COMMENTS:**

Besides my comments and observations mentioned above, I would also like to mention that I have caused specific searches to the extent and in the manner aforesaid. Further, I have presumed that xerox copies of the papers produced before me is in custody of the Present Owner, which need to be inspected and collected. I would also like to mention that the searches undertaken by me do not relate to any encumbrance or charge created by operation of law like statutory charges on default of payment of Income Tax, Sales Tax and other Government dues, and relate to encumbrances affecting the title and created by those act of parties which requires, under law, a corresponding record for the public in general at the offices at which I have caused to be made the specific searches as aforesaid.
