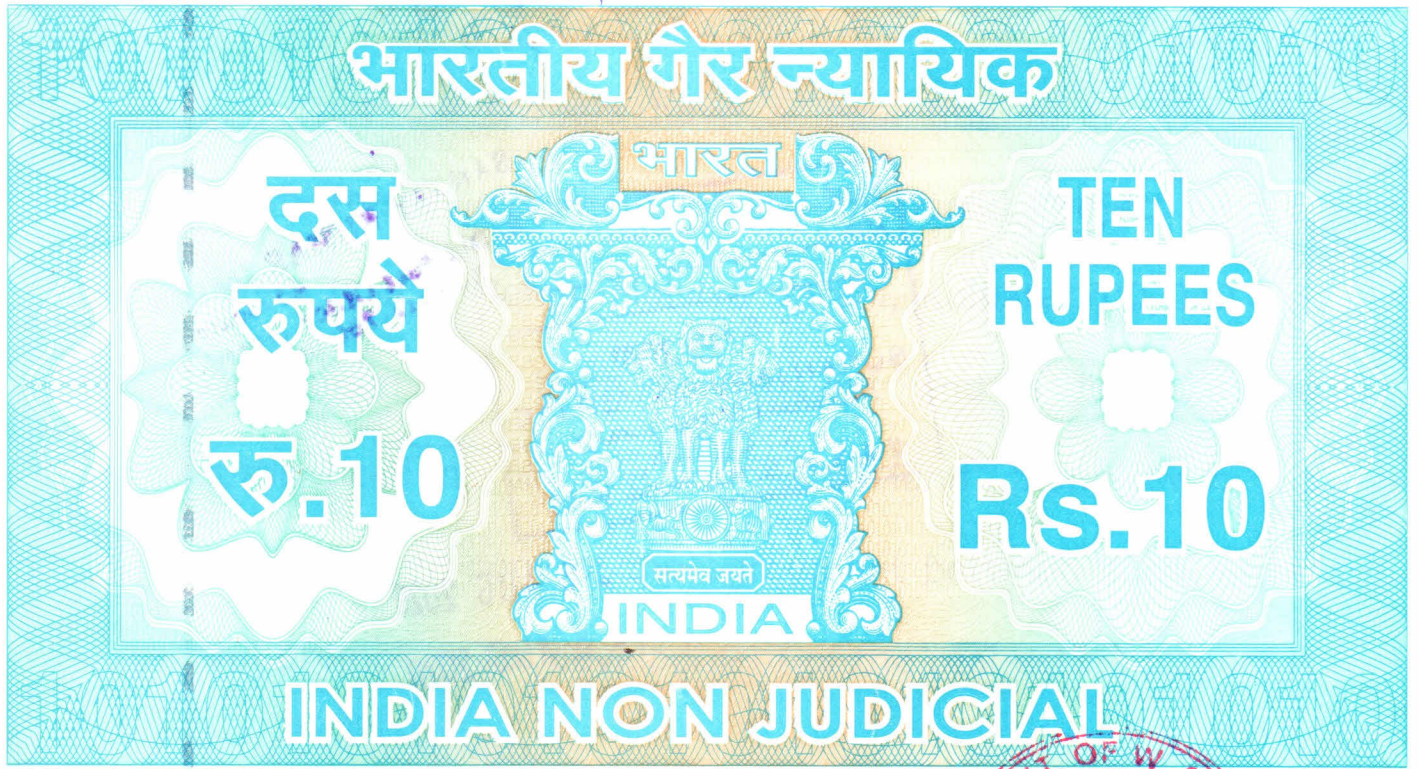

1. That the Owners have a legal title to the land on which the development of the proposed project at 16,

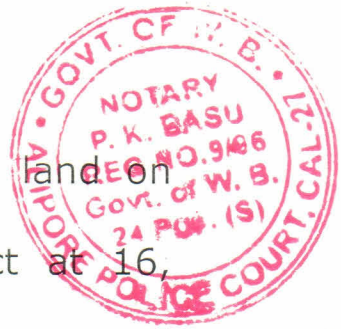

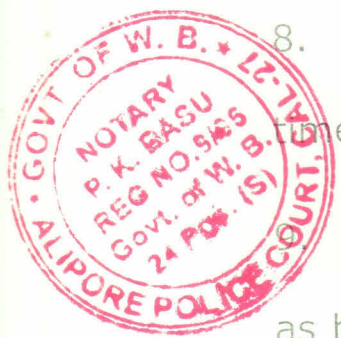

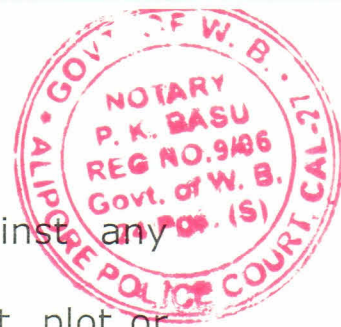
8. That Promoter shall take all the pending approval on time, from the competent authorities.

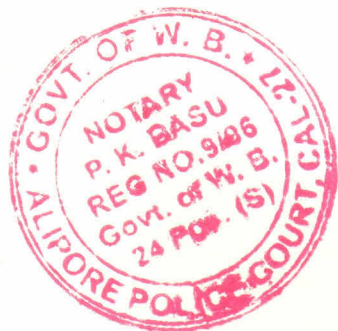
