That the Partnership Firm has a legal title to the land on which the development of the on-going project is carried out by virtue of a Joint Development Agreement with the owners of the Land (1) Sri Pradip Shome, son of Late Tejendra Shome and (2) Smt. Sraboni Shome, wife of Sri Pradip Shome;

AND

All legally valid authentications of title of such land along with an authenticated copy of the Agreement between such owners and the Partnership Firm for development of the real estate project are enclosed herewith.

- That the said land is free from all encumbrances.
- 4. That the time period within which the project shall be completed by the Partnership Firm within the date of 30th. December, 2020.
- 5. That seventy per cent of the amounts realised by the Partnership Firm for the real estate project from the allottees (per proforma agreement for sale), from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

That the Partnership Firm shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been outlised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

- That the Partnership Firm shall take all the pending approvals on time, from the VORTHCompetent authorities.
 - 10. That the Partnership Firm has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
 - 11. That the Partnership Firm shall not discriminate against any allottee or allottees at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
