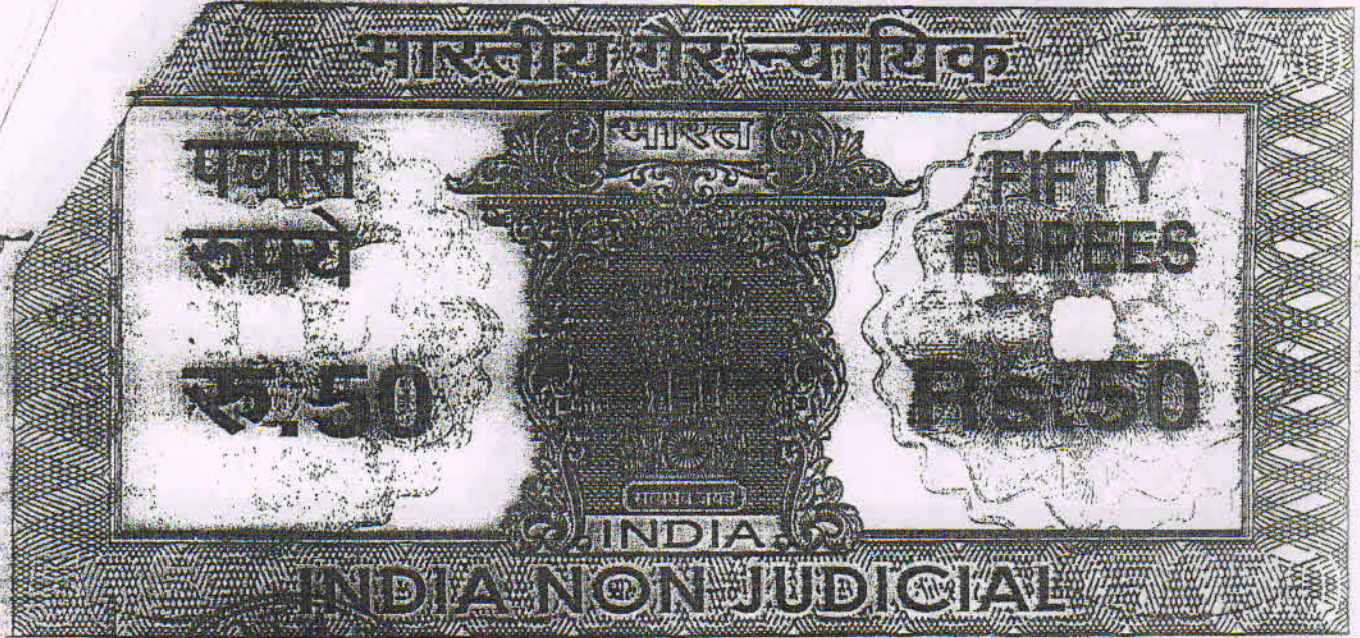

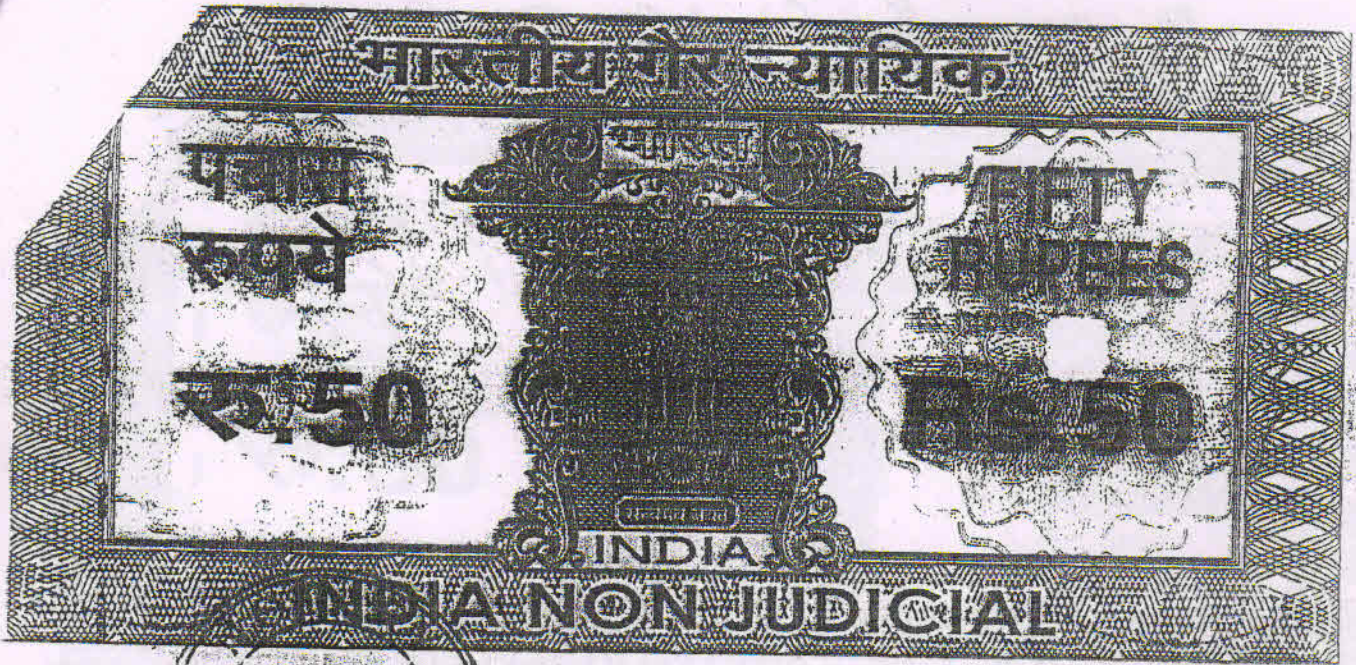

02. **CAPITAL** :- That Partner no.- 1 & Partner No.- 4 shall each contribute Rs. 50,000/- and Partner no.- 2 & Partner No.- 3 shall each contribute Rs. 25,000/- as initial capital. If further capital is required, it will be arranged by the partners themselves or from outside creditors, banks, Governments or from other financial institutions on terms and conditions mutually agreed upon by and between the partners and the loan creditors.

03. **SHARE OF PROFIT AND LOSSES** :- That the profits or losses in the partnership business after deducting all the outgoings and payment of salary, bonus, commission and interest on capital to the partners hereinafter mentioned shall be divided among the partners in the manners follows :-

- A) SHRI SATYABRATA SINHA :- 25 % (twenty five percent)

03A **REMAINING 10% SHARE** :- If the Firm make Profit then the remaining 10% (ten percent) shall always reserve for the Labour welfare of the Firm and it shall be distributed among the labours of the Firm and if the Firm make any loss then the remaining 10% (ten percent) shall always distributed among the Partners of the Firm in equal share in addition with their aforementioned (clause 3A) respective individual share.

04. **REMUNERATION AND INTEREST ON CAPITAL** :- That by mutual consent and agreement it is decided that all the partners are working partners and they shall be paid such remuneration by way of monthly salary, bonus and commissions and interest on capital as may agreed upon by the partners from time to time.

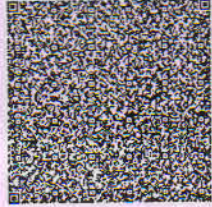

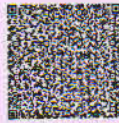

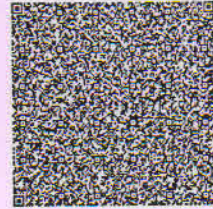
