This last Will or instrument of last Testament is to the effect following. My husband Sri Gangadhar Samonta is alive. We have six sons and eight daughters. I am executing this last Testament or Will in order to make arrangement in respect of the properties to be left behind by me after my death.

My third son Sriman Biswajit shall get the house and land situate at premises No.16, Mohanirban Road within the Corporation of Calcutta and the fallow land at 30C and 30D Gariahat Road, Panchanantala within the Corporation of Calcutta in absolute right.

Srimati Chabi Rani Debi wife of my second son Sriman Ranjit shall get the house with adjoining fallow land situate at holding No.63, Mahalla Sankharipukur within the Burdwan Municipality District Burdwan in absolute right.

My third son Sriman Biswajit shall get my land situate in Telaiya Mouza within the Police Station Koderma, District Hazaribagh.

If anybody wishes to sell my said properties to be left behind by me, in that event the same shall have to be sold to any one amongst my other sons.

My third son Sriman Biswajit Samonta shall get my shares in Nanda and Samonta Company Private Limited and the shares in Calcutta Building Society Limited.

Whatever cash money and amount in bank and ornaments etc., shall remain, all my liabilities shall have to be met out of the same and the remaining portion shall be distributed amongst my sons and the daughters who will remain alive at the time of my death in equal shares. If any son does not survive, the heirs of the said deceased son shall get the said share. The decision of my third son Sriman Biswajit shall be final in this respect and the same shall be binding on all.

As long as my husband Sri Gangadhar Samonta shall remain alive, he will remain in possession of all the aforesaid properties, none shall be entitled to create any kind of trouble in respect of his possession.

I cancel and revoke the Will which I executed prior to this. I appoint my third son Sriman Biswajit Samonta son of Sri Gangadhar Samonta by religion Hindu, occupation business, resident of Kanungobigha, Police Station Koderma, District Hazaribagh, State of Bihar the Executor to this Will. He will get Probate of this Will without furnishing security.
