- That Owner mentioned in the schedule hereunderhas a legal title to the land on which the development of the proposed project namely "Eco Exquisito" is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoters for development of the real estate project is enclosed herewith.
- 2. That the said land is free from all encumbrances.
