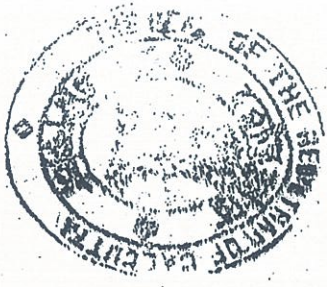

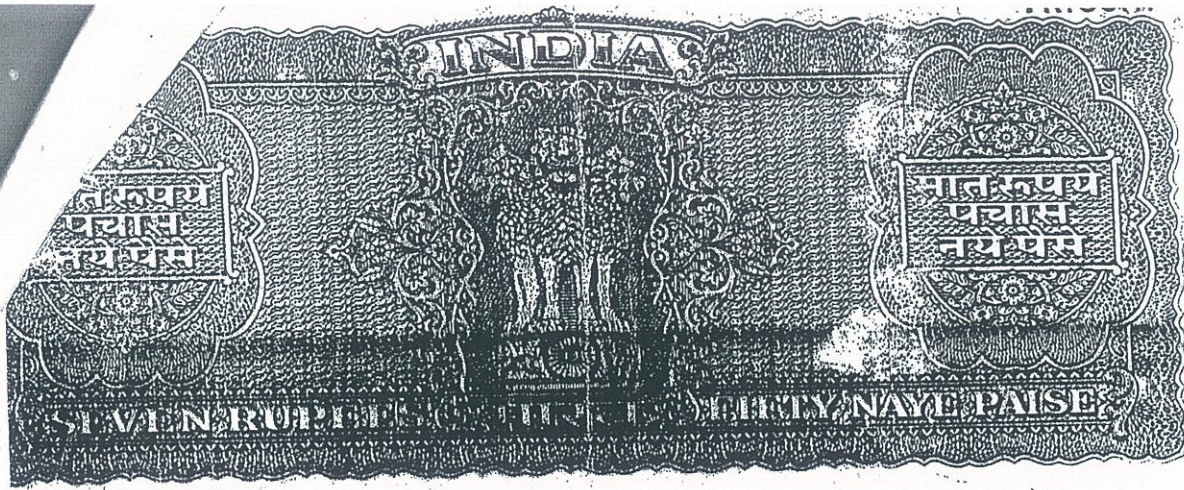
Whereas Sri Pradip Coomar is the youngest son of the SETTLOR who is also the certificated guardian of the said Pradip Coomar who is a minor.

And whereas the Settlor's cash monies have been invested in diverse businesses and out of which the SETTLOR intends to create the Trust Fund.

NOW THIS DEED WITNESSETH:-

1. That out of natural love and affection for her minor son Prodip Coomar who was born on the Third day of Nov. 1946 and for whom she has been acting as the certificated guardian for a long time past the SETTLOR hereby transfers and assigns all

the properties mentioned in the Schedule hereunder which belong to the SETTLOR TO Trustee upon trust and subject to the powers and provisions hereinafter expressed and declared.

2. That the said Trust will be henceforth known as "PRADIP COOMAR TRUST" and the cash monies amounting to Rs 5,000/- Rupees Five thousand only as 'Pradip Coomar Trust Fund' and the movables and immovable properties described in the schedule as 'Pradip Coomar Trust Properties'.

3. That the SETTLOR appoints herself as the Trustee or the First Trustee so long as she is alive but not incapacitated and thereafter her husband Sri Benoy Pada Coomar will be the Trustee by virtue of this Deed. The First trustee reserves the right to nominate any other Trustee in case the occasion so requires, Pradip Coomar will be the beneficiary and thereafter his sons will be beneficiaries.

4. That the Trustee shall not transfer the immovable properties of the Trust hereby conveyed, except in case of absolute and unavoidable necessity or for the purpose of better investment.
