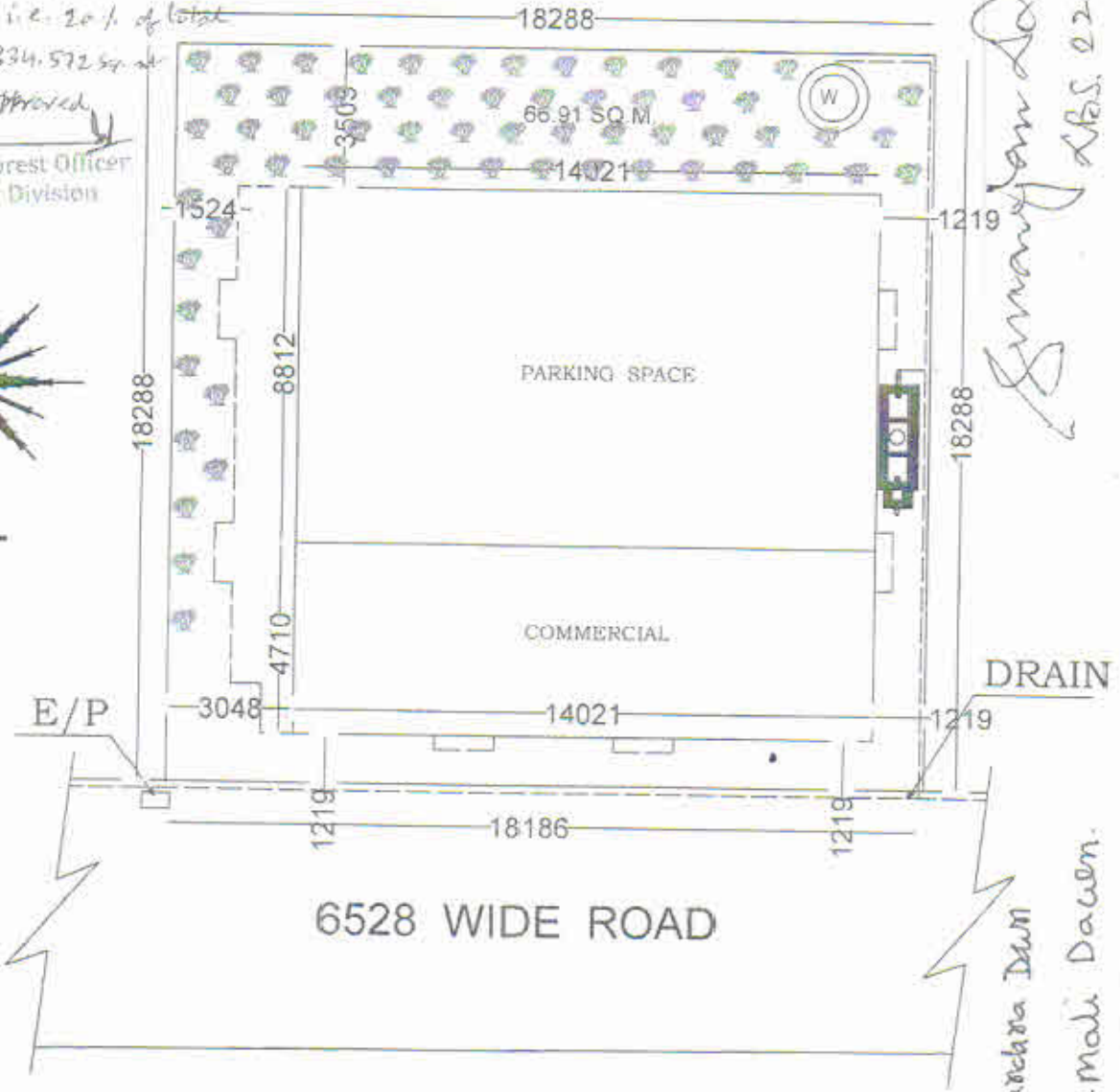
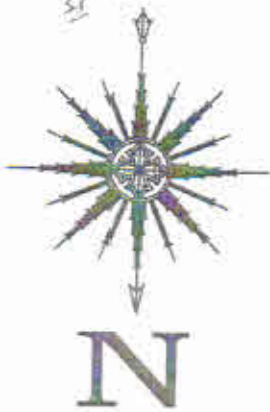


**THE PLAN SHOWING THE PLANTATION AREA PROPOSED GROUND + THREE STORIED
