

The total income of the company has decreased from last year '1001.58 Lakhs to '717.38/- Lakhs and Profit before Tax also decrease from last year '461.52/- Lakhs to '279.81/- Lakhs. The Earnings per share of the company has decrease from '251.17 to '152.19.

Report on the Financial Statements
