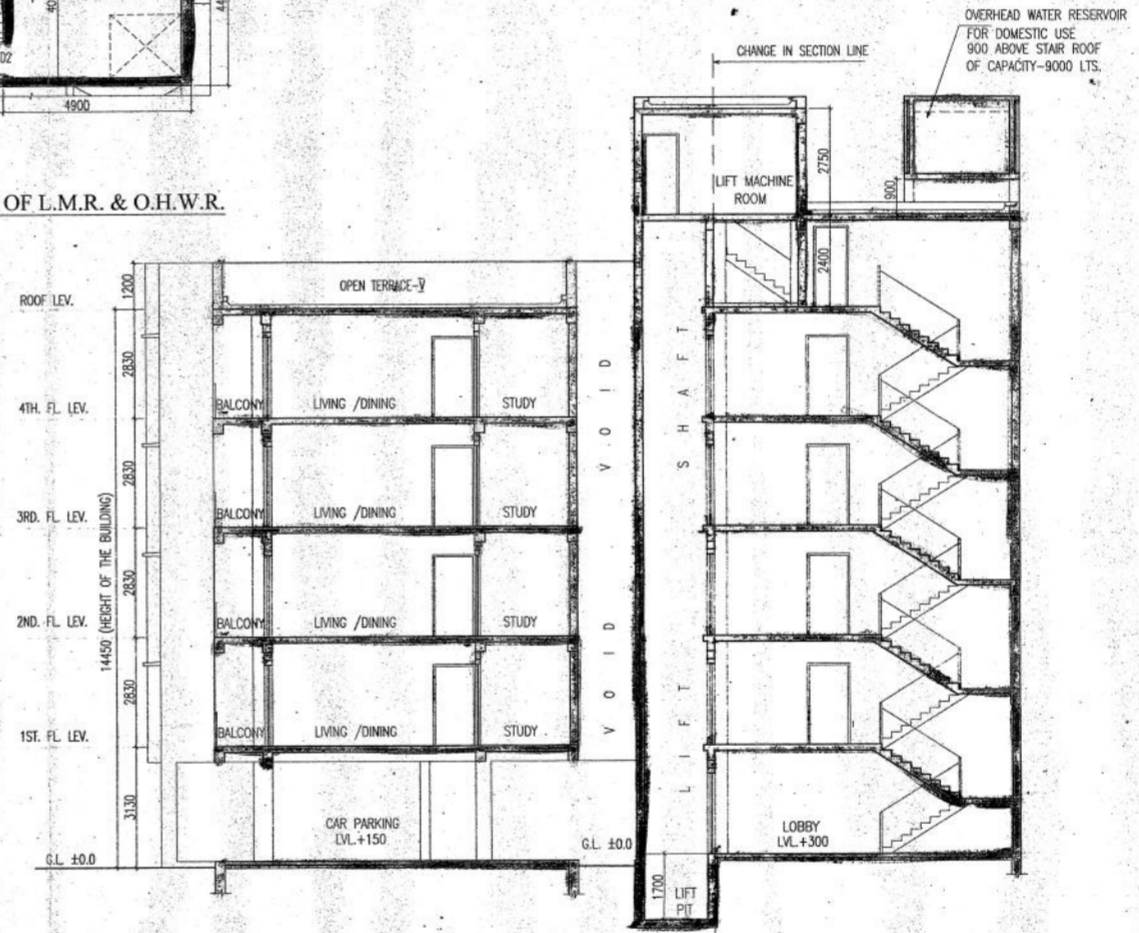
FRONT ELEVATION



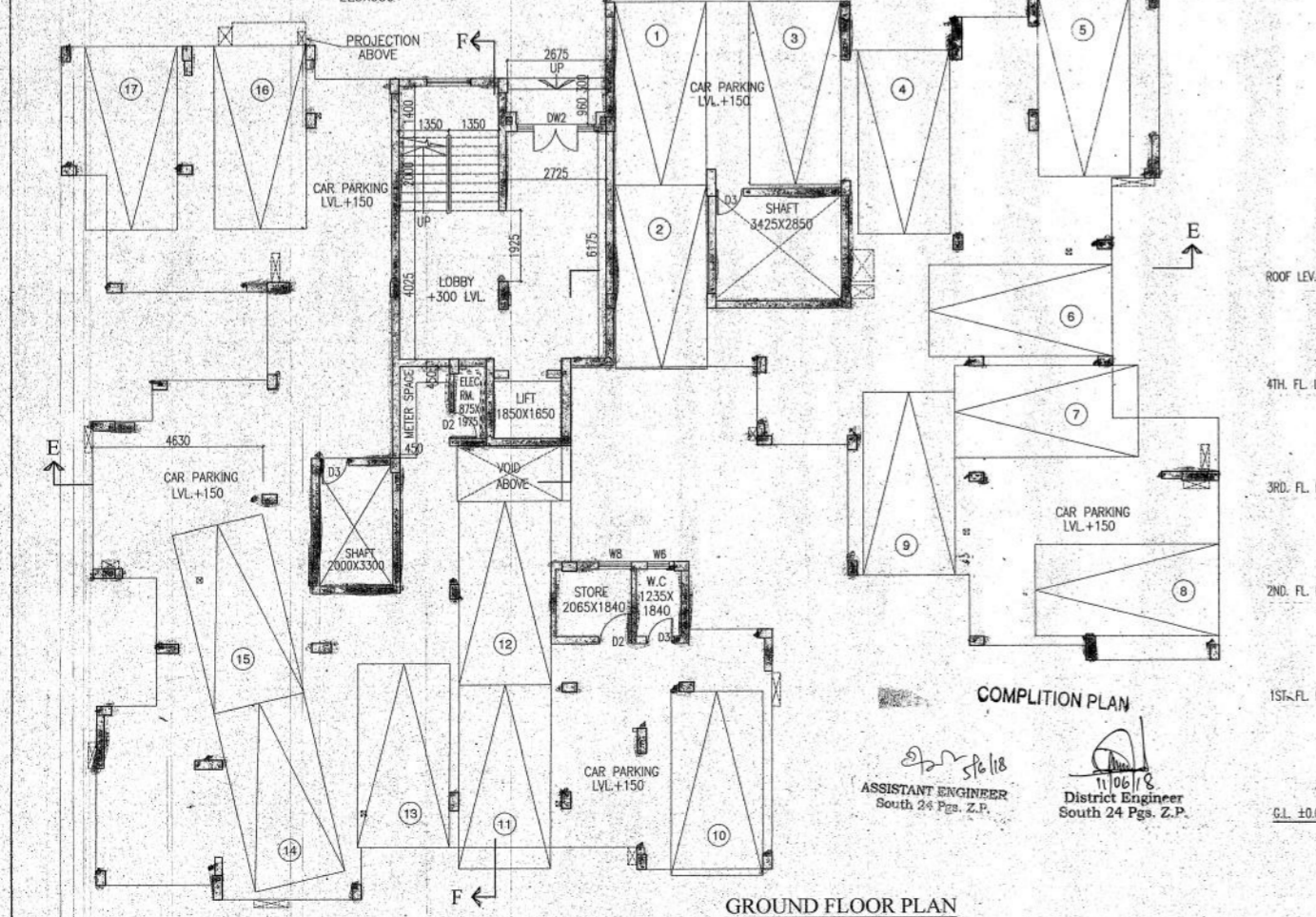
PLAN OF L.M.R. & O.H.W.R.



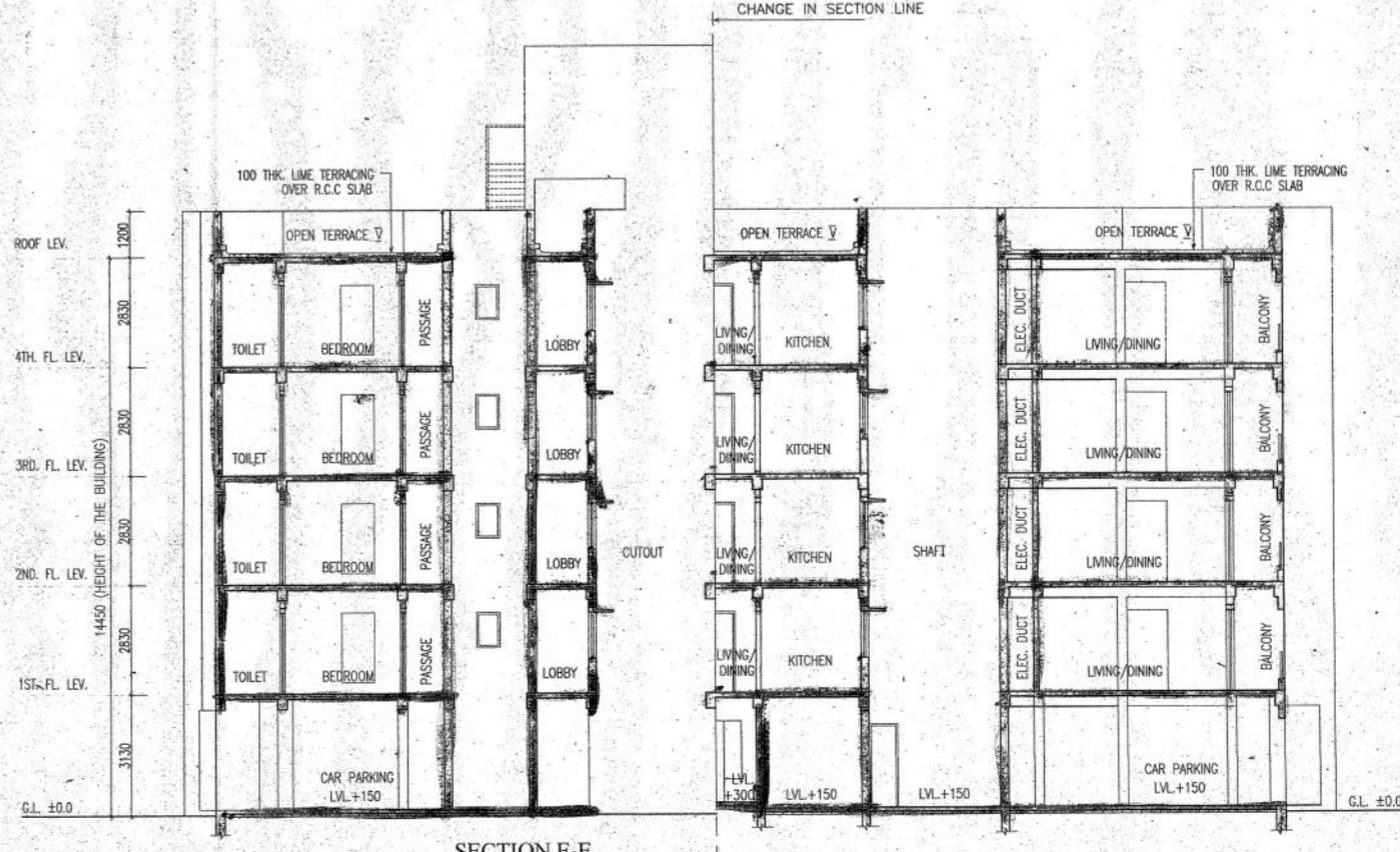
TYPICAL FLOOR PLAN (1ST. TO 4TH. FLOOR)
