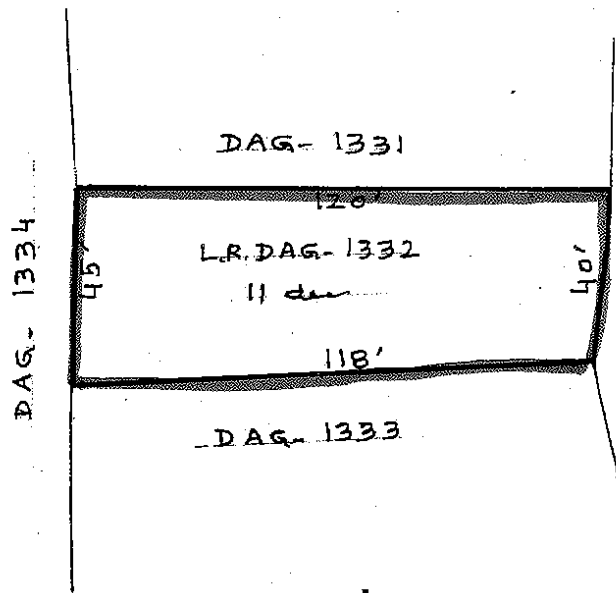
SITE PLAN
