Under the circumstances the time period of 15 days as stipulated by this Authority is expiring on 28.08.2019, thus we pray before this Authority, to kindly allow us the Registration no. for the said project, and we are ready to declare the issue regarding the Plan Sanction on Affidavit and submit the same before this Authority.

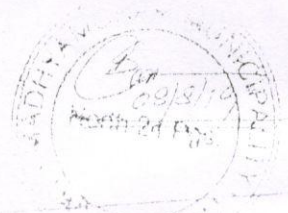
