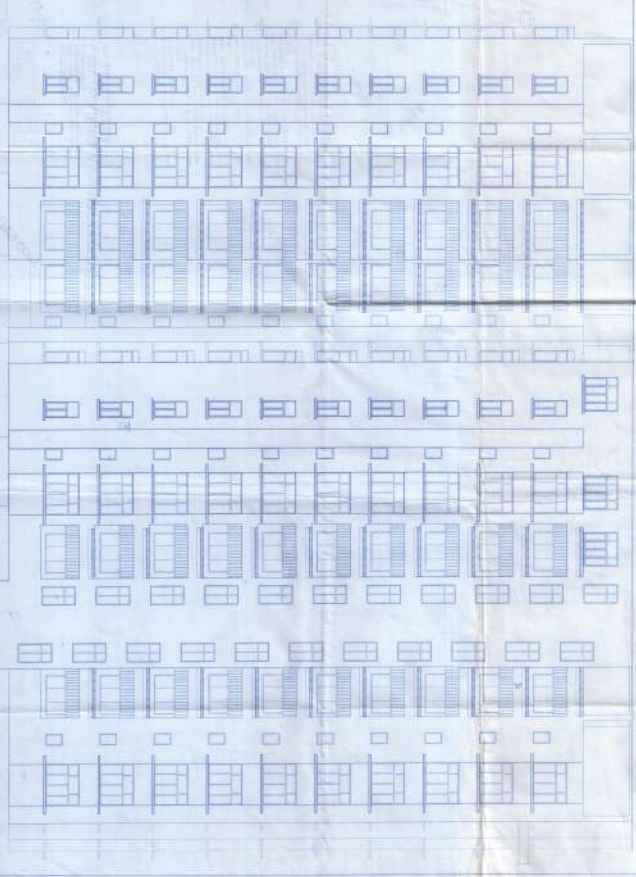

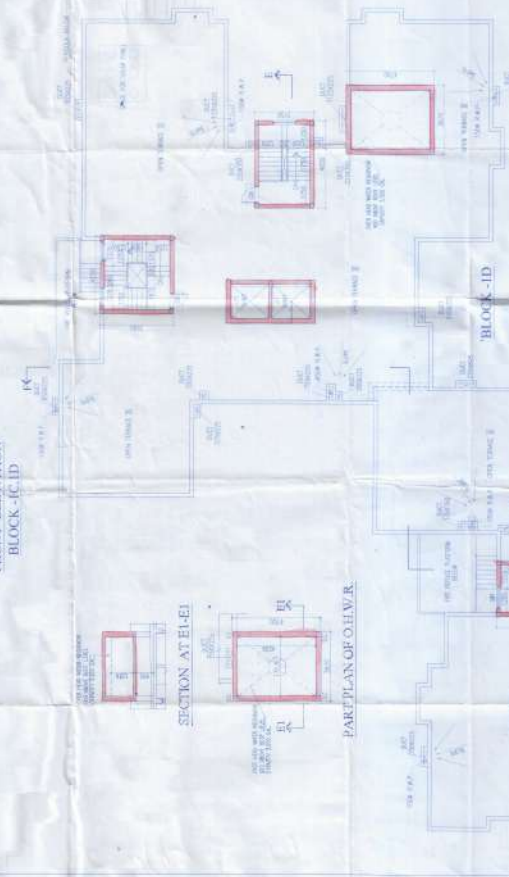

 BLOCK-1C, ID



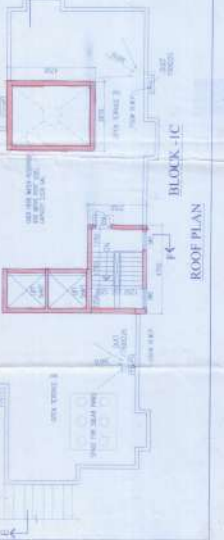
ROOF PLAN
