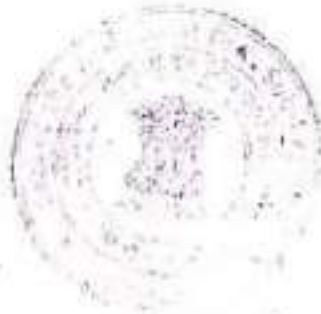

all residing at 82, Chinta Moni Dey Road, within the jurisdiction of Police Station named Howrah, in the District of Howrah, hereinafter called the 'developer/second party' (which expression unless contrary to or repugnant with the context of this Deed shall include their heirs, successors-in-interest, executors, administrators, transferees and assigns).

WHEREAS by virtue of a deed of partition dated 24 January 1955 various parcels of properties were partitioned among the four shareholders.

AND

WHEREAS the said deed of partition witnessed that Aditya Nath Kundu, Paresh Nath Kundu, Rash Behari Kundu, Sita Nath Kundu, Amiya Nath Kundu, all sons of late Satish Chandra Kundu and Sm. Durgabala Dasi, wife of late Satish Chandra Kundu joined the above deed of partition to represent the second group of allottees.

AND

WHEREAS the aforesaid deed of partition was duly registered before the Sub-Registrar of Howrah and the deed was duly recorded in the said Registry in Book no.1, volume

no.117 in pages 465 to 486 being no. 6780 for the year 1955.

AND

WHEREAS since the aforesaid allotment in the above deed of partition, the said second group of allottees became seized and possessed of the properties allotted to them jointly and they mutated their names in respect of the said property and they continued to exercise their rights of ownership over the same without any interference from any corner.

AND

WHEREAS while being so seized and possessed of the said properties the aforesaid first person of the second group of allottees in the above deed of partition, viz. Aditya Nath Kundu expired in or about 1967 and at the time of his death he left his wife, viz. Sm. Sovalata Kundu and three sons, viz. Bibhas, Amaresh, Aparesh and six daughters, viz. Ava, Seba, Ita, Sweta, Supta and Dipta.

AND

WHEREAS the aforesaid heirs of Aditya Nath Kundu stepped into the shoes of their predecessor-in-title and they remained in joint occupation of the said properties inherited from him and while so seized and possessed of the said properties the aforesaid six sisters along with their mother executed and registered a deed of gift dated 25 september 2012 in respect of the properties inherited by them from Aditya Nath Kundu in favour of their two brothers, viz. Amaresh and Aparesh & anirban son of predeceased brother bibhas and they became destitute of any interest in

the properties which they inherited from Aditya Nath Kundu. Bibhas Kundu died in 2003 and he left his wife since deceased and son being the 8 of the first party to inherit the estate left by him.

AND

WHEREAS the aforesaid Paresh Nath Kundu, one of the members of the second group of allottees in the above deed of partition died in or about 1985 and his wife having predeceased him he left at the time of his death his four sons being Bikash, Pabitra, Pranab and Biplab and three daughters being Dipa, Rita and Mita and the aforesaid heirs of Paresh Nath Kundu remained joint in estate inherited by them from their father along with other co-sharers.

AND

WHEREAS while so seized and possessed of the properties inherited from Paresh Nath Kundu the aforesaid three daughters, viz. Deepa Mashat, Rita pal and Mitali de transferred their entire interest in the property which they inherited from their father by way registered deed on 3<sup>rd</sup> October 2012 of gift in favour of the three brothers, viz. Pabitra, Pranab and Biplab and one nephew, viz. Tridib son of late Bikash kundu and they became destitute of any interest in the property which they inherited from Paresh Nath Kundu.

AND

WHEREAS Bikash Kundu died in the year 2010 and at the time of his death he left his wife, viz. Sm. Chandra Kundu and one son , viz. Tridib Kundu, and one daughter, Mithu Konui who jointly inherited the estate left by Bikash Kundu.



The said Chandra kundu died and her interest devolved upon her issues as above.

AND

WHEREAS the aforesaid Sitanath Kundu died in the year 2011 and at the time of his death he left his wife, viz. Sm. Surama Kundu and three sons, viz. Amitava Kundu, Arunava Kundu, and Pulak Kundu and Sm. Rita Kundu, wife of pre-deceased son, Goutam Kundu and one grandson, viz. Sourav Kundu. Surama Kundu died and her interest devolved upon her above heirs.

AND

WHEREAS on the aforesaid change of interest on the demise and consequential devolution upon the heirs, the said property allotted to the second group of allottees in the aforesaid partition deed came to be represented by the first party of this agreement.

AND

WHEREAS Amiyanath kundu died on 02.03.2017 leaving his wife named Usha Kundu and two son Subhaue kundu and Kaushik Kundu.

AND

WHEREAS the first party being seized and possessed of the properties described in some details in schedule 'A' hereunder, mutated their names in the records of Howrah Municipal Corporation as well as in the Settlement Record of Rights and have been continuing to deposit the taxes and revenues before the said authorities.

AND

WHEREAS on the passage of time the properties in Schedule 'A' is required to be developed for the purpose of providing additional accommodation to the growing family of the first party and in the absence of requisite funds, experience and time, the first party being unable to prosecute that objective, searched for a competent developer to undertake the responsibility of development of the land described in Schedule 'A' and the first party further approached this developer/second party to undertake such work of development of the properties in Schedule 'A' by constructing upon the said property building having maximum height permitted under the law and utilizing the space to the maximum extent possible and the second party being engaged in similar types of work with repute and the second party agreed to undertake such work of development subject to certain conditions.

AND

WHEREAS between the parties herein a consensus was reached which is described in this agreement for the purpose of development of the property in Schedule 'A'.

NOW THIS DEED WITNESSES AS FOLLOWS :-

- (1) That the first party has engaged the second party as the developer of the property in Schedule-A and the second party has accepted the responsibility to develop the premises in Schedule-A subject to the terms and conditions as stated hereinbelow.
- (2) That the first party shall deliver unto the second party the original documents of the premises in schedule hereunder in the custody of the second party who shall be the custodian of such documents till the conclusion of the

project herein embarked by the parties and on the closure of such project the second party shall deliver unto the first party the documents mentioned above in the possession of the first party. Such document in original shall be handed over to the second party by the first party immediately on the execution of this agreement.

- (3) That the first party shall allow the second party to enter into the premises described in Schedule-A and to take due measurements of the same and if necessary, the second party would invite the first party to enlighten upon the facts and/or documents and the first party shall to the best knowledge and belief satisfy the second party about the queries that may be put by the second party.
- (4) That the second party has undertaken the responsibility to develop the properties in Schedule-A hereunder and raise a building or buildings having G plus 10 (G+ 10) storeys or the buildings having the maximum height as may be permitted by the municipal authority and in this matter the second party shall strictly follow the building plan as may be sanctioned by Howrah Municipal Corporation.
- (5) That the second party shall prepare an appropriate building plan by a competent draftsman and shall submit such building plan before the municipal authority and shall proceed and pursue the said building plan and pay all necessary cost therefor and shall inform the first party about such receipt of sanction upon the building plan. In this connection, it is stated that the first party shall execute a general power of attorney in favour of the second party for doing all necessary work for development of the premises including the drafting of the

building plan and to put the signature as the attorney of the first party.

- (6) The second party shall complete the project by raising a building or buildings as stated above within a period of 60 months to be counted from the date of sanction of the building plan or the delivery of vacant possession of the property described in Schedule-A whichever would be later.
- (7) The second party shall construct the buildings upon the land of the existing structures and shall try to construct the 20 flats in the old space within the period of 48 months from the date of sanction of the plan or the delivery of vacant possession of the landlords/First party Seven have already been accommodated in good rented flats at the cost of the developer. In case not delivery in 48 months the second party will compensate for delay @200/- per day per flat.
- (8) That following the aforesaid building plan duly sanctioned by Howrah Municipal Corporation the second party shall construct upon the land in Schedule-A strictly in compliance with such plan by using the standard building materials and by engaging competent masons, engineers and architects solely at their cost.
- (9) That the nature of the construction, the particulars of the fixtures, fittings etc of the said building or buildings to be constructed upon the premises in Schedule-A hereunder are described in Schedule-B.
- (10) That the second party shall duly proceed with the construction of the building as agreed upon and in terms of the building plan duly sanctioned by Howrah Municipal

Corporation and while doing construction if any accident is caused, the first party shall not bear any liability which will be fastened to the second party and in case of any civil dispute between the first party and the neighbours or anybody else, the first party shall effectively cooperate with the second party in order to solve the civil dispute, if any.

- (11) That the second party shall construct the building carefully and by applying scientific methods and if, in the course of such construction, any defect would be detected by the first party, they should immediately in writing inform the second party and both the parties herein in consultation with the engineer in the project shall try to solve it and in case no complaint would be made by the first party, it would be deemed that the work of development is faultless and no further complaint in future can be made against the second party.
- (12) That the parties have agreed and accepted that the ratio of share of construction upto the fifth storey (G+4) shall be 40% for the owners and 60% for the Developers. The said ratio of share of construction above fifth storey shall be 30% for the owners and 70% for the developers. Developer shall allot 20 (twenty) flats allotted to the owners as a whole to be divided among the owners by themselves in one complete building. Further besides the above covered area of the twenty flats the owners shall get the right of user of the super built up area and the common space. The owners shall have no claim over any part of the built up area in excess of the share of the owners and the same shall vest exclusively in the developer in their share of construction. It is agreed that in case the 20 flats would be provided to the first party in

block A in that case distribution of flat to the first party shall be from the Second floor to Eighth floor.

- (13) That the parties have agreed and accepted that second party will assure that first party shall get 600 Sqft Built-up area per flat and this distribution will be valid upto eleventh floor. This ratio 30% for owner and 70% for developer continue above eleventh floor. If the developer obtains permission for construction of additional floor space Above eleventh floor the owner's 30% area shall be valued at the then market price and distributed to the owners according to shares. However, the second party shall first try to give to the first party area of the construction and failing to do as such the above value shall be given and in this respect the decision of the second party shall be final.
- (14) The second party shall issue appropriate documents for possession in favour of the first party who shall take a joint share which they would occupy jointly without disturbing the second party for separate distribution of floor space unto them. However, the second party shall provide the necessary papers for mutation individually to the members of the first party.
- (15) That the second party shall have the right to enter into private agreement with prospective purchasers to dispose of their share of floor space together with the proportionate share of land beneath unto the prospective purchasers and to receive the earnest money or the booking money or advance and to execute the agreement for sale and register such agreements, if necessary. However, the first party shall not be bound by any private monetary transactions or whatever transaction the second

party shall enter into with the outsiders nor will they be liable for the aforesaid agreements.

- (16) That the second party shall have the right to receive the aforesaid earnest money, advance or booking money and the consideration for the floor space for purchase in their share and they shall sell the floor space with proportionate share of land beneath and register the conveyances and at the same time distribute the flats to the First Party.
- (17) That the second party as the constituted attorney of the first party shall have the right to represent the first party before the Municipal Corporation or the departments of government, the electricity supply authority or any statutory government or private authority by virtue of the power of attorney the first party shall execute in favour of the second party simultaneously with the execution of this agreement for development.
- (18) That the first party shall not, during the continuance of this agreement, enter into a similar type of agreement for development with any other party or parties and in case the first party shall do such act in violation of this agreement, the aforesaid agreements subsequently made in violation of this agreement shall be void ab initio.
- (19) That the first party shall cooperate with the second party in all respects to execute the agreement for development made herein and they shall not in any way impede the development nor will they cause unnecessary troubles to the second party in the matter of executing the terms of this agreement.

- (20) That the first party shall under no circumstances terminate this agreement for development after the second party has obtained the building plan duly sanctioned by Howrah Municipal Corporation. However, in case of any violation of any terms of this agreement by the second party, the first party shall have the right to inform the second party pointing out the said violation in order to enable the second party to put the things to correction if necessary and in case the second party refuses to amend the serious mistake, if any, the first party shall have the right to terminate the agreement provided the first party shall, before such termination, pay the entire cost incurred by the second party together with 10 per cent interest thereupon.
- (21) That the first party further agrees that in case the second party wants to execute the terms of this agreement together with agreements for development of properties adjacent to the properties in Schedule-A hereunder, the first party shall in advance declare their consent to it and that the first party shall not ask for any further pecuniary benefits or benefits in the matter of ratio from the second party.
- (22) That the roof of the building or buildings the second party would construct under this agreement shall remain in full occupation of the first party and the second party in terms of the ratio declared hereinabove.
- (23) It is agreed that the entire land in 98, Mahendra Bhattacharjee road shall be developed such that commercial and residential floor spaces shall be constructed and this developed part of 98, Mahendra



Bhattacharjee road shall belong exclusively to the developer.

- (24) That the first party shall execute a general power of attorney in favour of the second party for doing all types of general work on behalf of the first party empowering and authorizing the second party or any partner of the second party to execute documents being agreement for sale or the deeds of sale in respect of the share of floor space together with the proportionate share of land beneath falling to the credit of the second party and to present such documents before the Registration office and to do any and every act at the Registry offices to complete the transaction of sale. However, the second party while acting under the aforesaid general power of attorney shall have no right to make transfer or mortgage of any part of the floor space together with the proportionate share of land beneath falling to the credit of the first party.
- (25) That the parties herein agree that there shall be an Association of floor space owners in respect of the buildings constructed over the land in schedule-A hereunder along with the owners of similar units of the floor spaces and the Association of the floor space owners shall determine the rules of maintenance of the buildings as well as the individual units of the said floor space owners. All occupiers will mutate their names in Howrah Municipal Corporation and install electric meters and pay charges and taxes in their names. The Members of the first party shall regularly pay the taxes and revenues.

- (26) That during the period after construction of the buildings and the formation of the floor space owners association, the first party or any representative of them chosen by the first party shall be in charge of maintenance of the building and during the continuance of his office a charge of Rs. 1/- per sq. feet shall be paid by the unit-holders to such person of the first party and no one shall question the quantum and propriety of such fixation of rate.
- (27) That the parties do hereby agree that in respect of the developed project as well as disposal of the separate units of the floor space to outsiders all types of documentation shall be done by Mr. Prabhat Kumar Banerjee, Advocate and the cost thereof shall be borne by the purchasers and the parties herein.
- (28) That this agreement has been meticulously read and considered and understood by the parties herein and they have given their free consent to it and they have complete consensus in the terms and conditions made herein and they executed the same voluntarily free from any influence affecting their capacity for contract.
- (29) That the owners of the floor space shall pay proportionate share of occupiers tax as used to be calculated by the landowner/promoter with reference to the Municipal tax bill since the date of their assuming possession of the respective floor space till the date of assessment of their respective taxes pay the municipal corporation and such proportionate taxes shall be collected by the landlord/promoter on receipts and the landlord/promoter shall pay the collected taxes along with the owners share to the Municipal Corporation.

**SCHEDULE - B****DESCRIPTION OF THE NATURE OF CONSTRUCTION,  
FIXTURE AND FITTING ETC.**

- 1) R.C.C. framed structure as per recommendation of soil expert.
- 2) 8", 5" and/or 3" brick work cement sand and inner walls with plaster of paris finish.
- 3) Marble flooring with 6" height skirting on all sides of wall.
- 4) All windows will be made of Aluminium sliding with ornamented grill and glass panel.
- 5) Flush door shutters of commercial quality with timber frame.
- 6) Marble stone on kitchen top with provision of color ceramic tiles upto 3'-0" on wall in front of kitchen top along with sink basin.
- 7) Flooring of marble and color ceramic tiles over wall upto 6 Ft heights with provision of chromium plated fittings, shower, washbasin.
- 8) All electrical wiring will be concealed with adequate point as per description of the promoter.
- 9) 24 hours water supply at each flat will be available from deep tube-well through overhead reservoir.
- 10) One point for antenna cable and one point for telephone cable will be available.
- 11) One side teak ply door for main gate only.

- 12) The Corporation water will be arranged on the individual flat owner's cost.
- 13) Sufficient space for air, light and passage.
- 14) Provision for hot and cold-water system in one bathroom.
- 15) 6-passenger lift of reputed make in each building.
- 16) Any other arrangement beyond these specifications will be made against extra payments.
