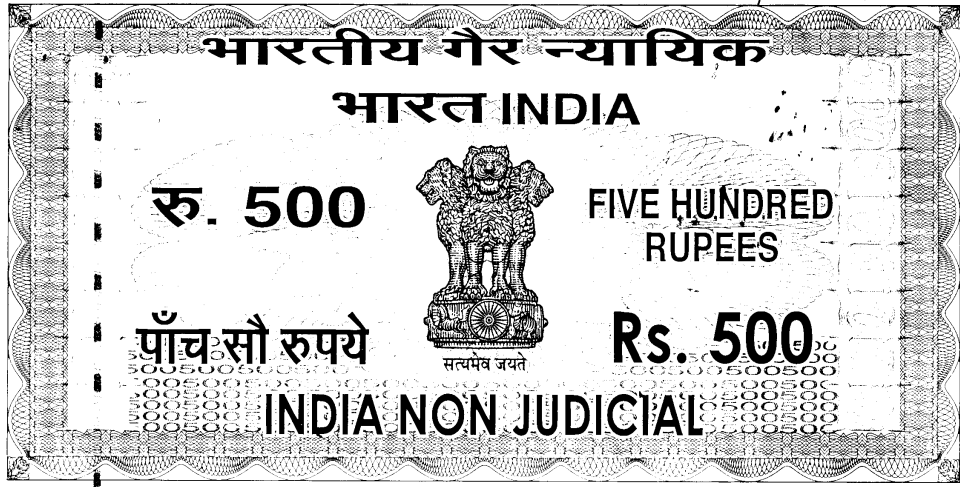

8. Thereafter by a Deed of Conveyance dated 26.08.2008 registered in the Sub Registrar Office at Bishnupur and recorded in Book No. 1, Volume No.12, Pages from 118 to 155, Being No.3680 for the year 2008 the said Balai Mondal, mentioned therein as vendor, had sold and transferred his said entire undivided share of land acquired by him admeasuring about 7.53 Decimal (3.58 Decimal pertaining to R.S. Dag No. 239 under R.S. Khatian No.244, 279 and 2.15 Decimal pertaining to R.S. Dag No. 276 under R.S. Khatian No.252 and 1.8 Decimal pertaining to R.S. Dag No. 277 under R.S. Khatian No.256) and some other lands under Pargana Magura, Collectorate Touzi No. 14, J.L. No. 20 under Mouza Bhasa, Police Station Bishnupur, Dist. 24 Parganans (south) in favour of the present owner, M/s. Paharpur Cooling Towers Ltd., mentioned therein as the purchaser.

Khatian No.256) Pargana Magura, Collectorate Touzi No. 14, J.L. No. 20 under Mouza Bhasa, Police Station Bishnupur, Dist. 24 Parganans (south) more fully and particularly described in the schedule written hereunder and hereafter called and referred to as the "said Property" the Vendor Company does hereby grant, transfer, convey, sell, assign and assure to and unto and in favour of the Purchaser Company free from all encumbrances all that the schedule land drains, water, water courses, water supply, electricity and sewer line and other pipe lines etc. and other rights, liberties, easements, quasi-easements, appendages, appurtenances

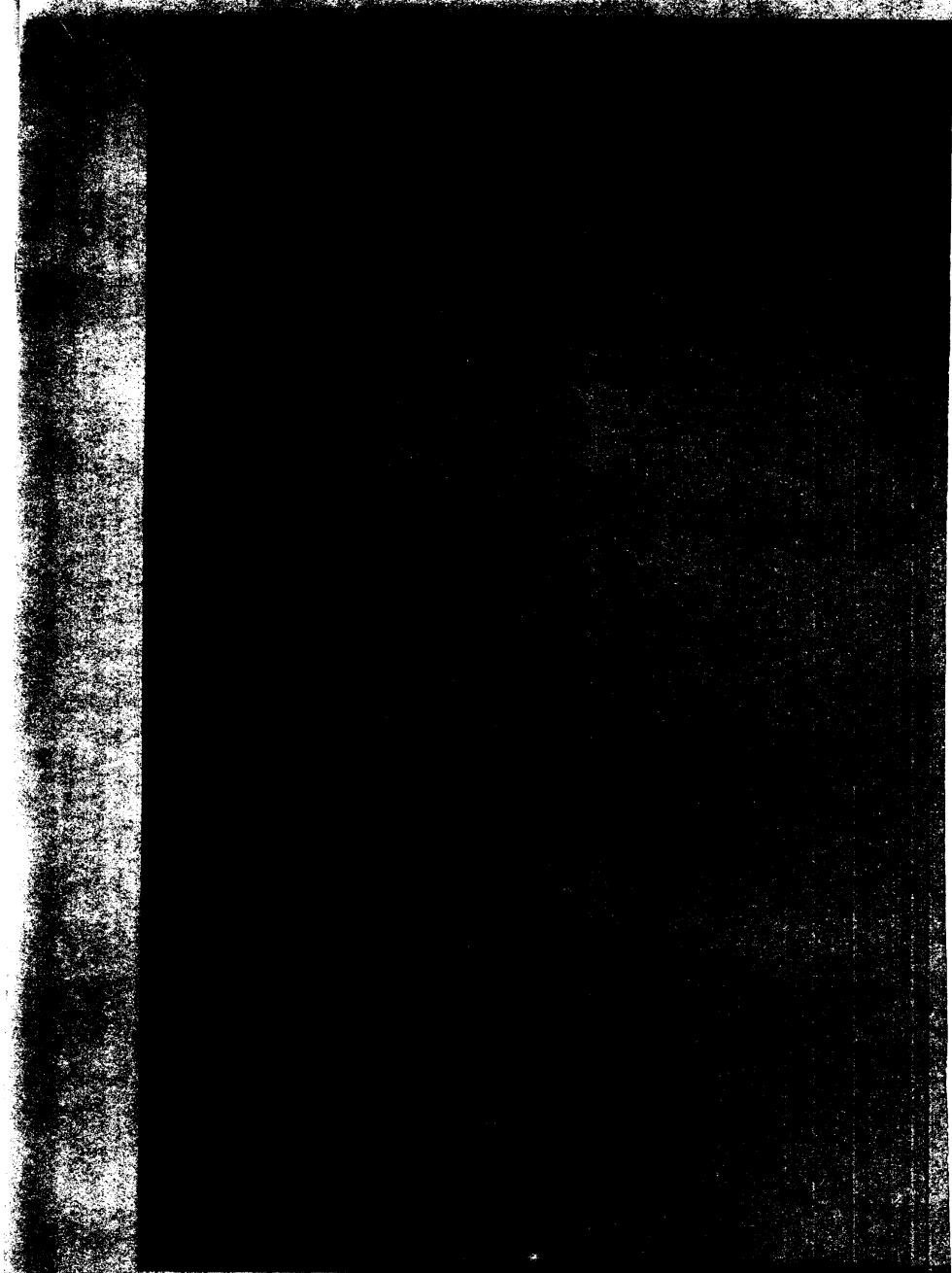


