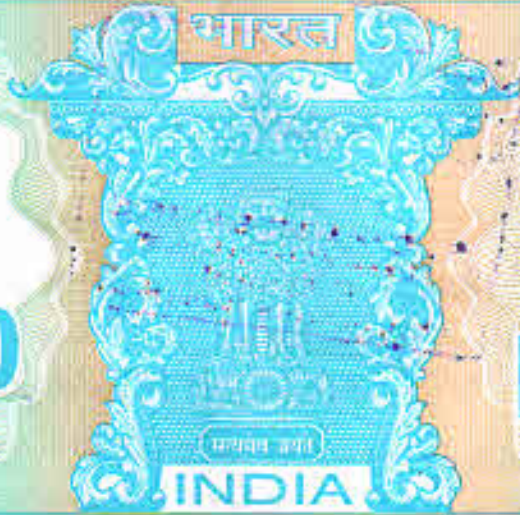

Affidavit cum Declaration of M/S. 1. That M/S. IABA HOUSING PRIVATE LIMITED represented by its Director Mr. Shakti Dhar Suman has a legal title to the land on which the development of the project is proposed.

A legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

2. That the said land is free from all encumbrances.
3. That the time period within which the project shall be completed by M/S. IABA HOUSING PRIVATE LIMITED, being the promoter of the project is 60 months from the date of allotment (Completion Date September 2026)
4. That seventy percent of the amount realised by M/S. IABA HOUSING PRIVATE LIMITED for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
6. That M/S. IABA HOUSING PRIVATE LIMITED, being the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project
7. That M/S. IABA HOUSING PRIVATE LIMITED shall take all the pending approvals on time, from the competent authorities.
8. That M/S. IABA HOUSING PRIVATE LIMITED has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
9. That M/S. IABA HOUSING PRIVATE LIMITED shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
