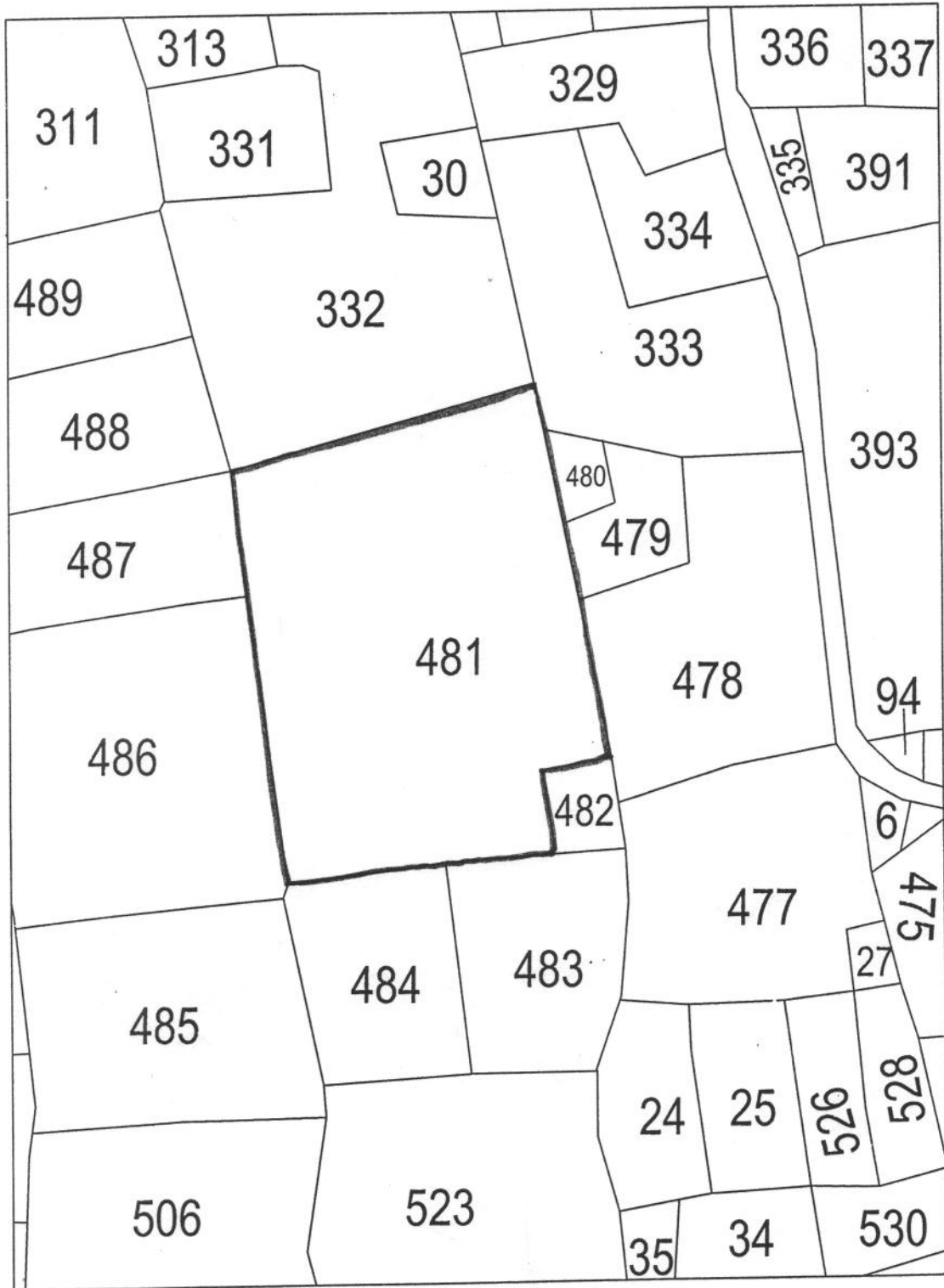

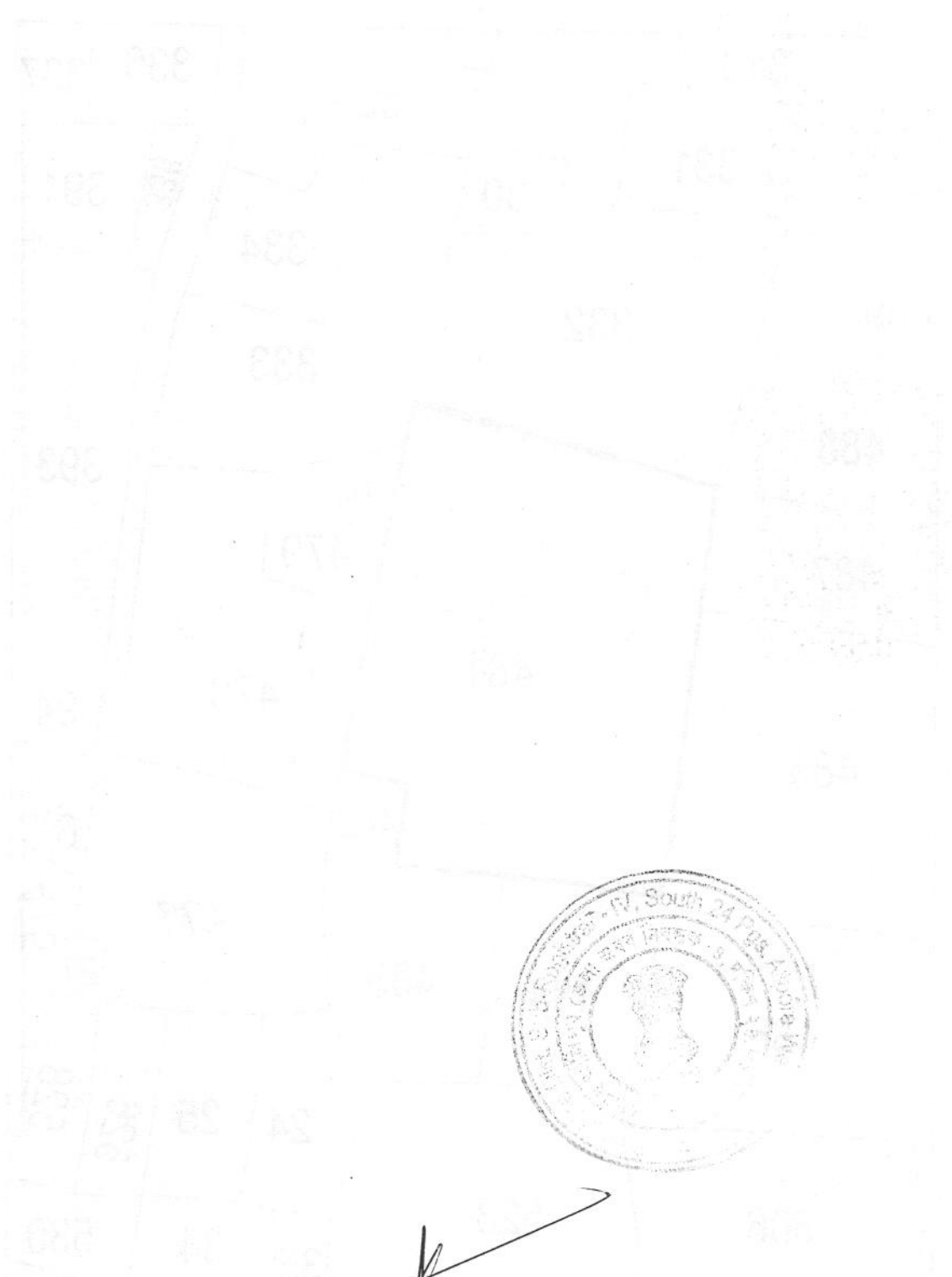


DEED PLAN OF THE L.R. PLOT-481, MOUZA MANIKPUR, J.L. NO-77
