SHOWN IN RED BORDER

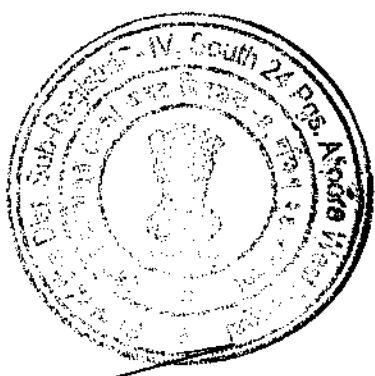

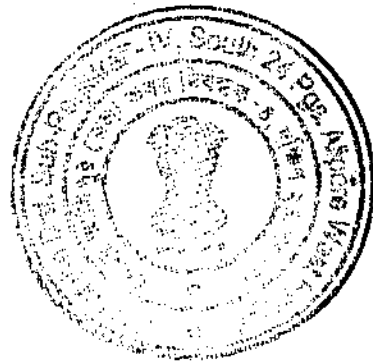
