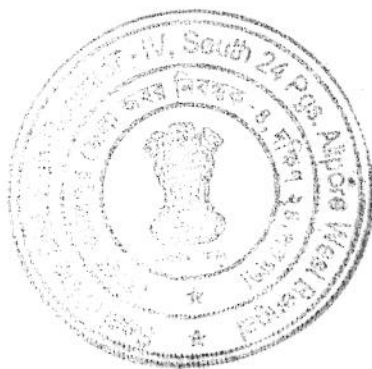

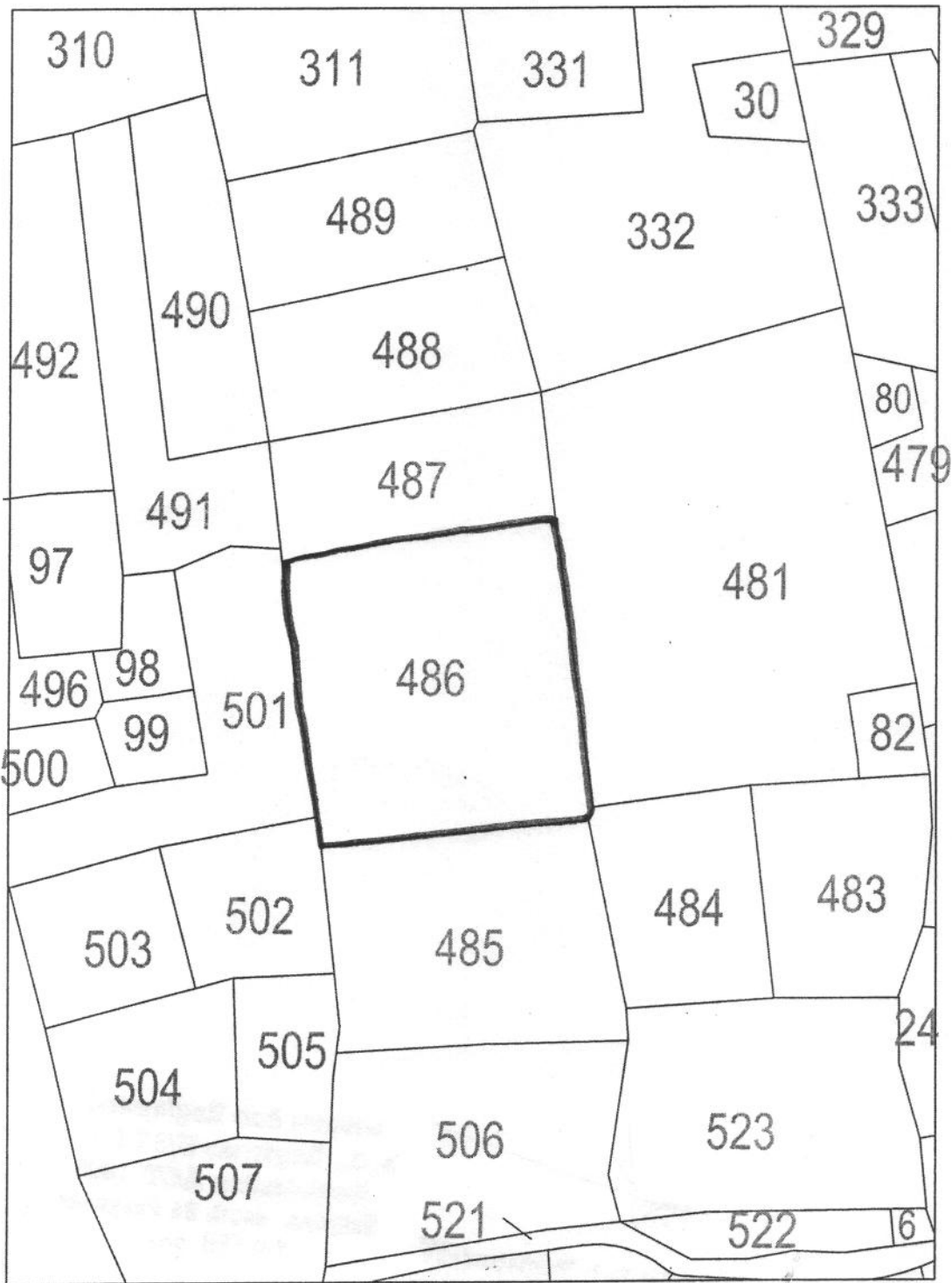

SHOWN IN RED BORDER



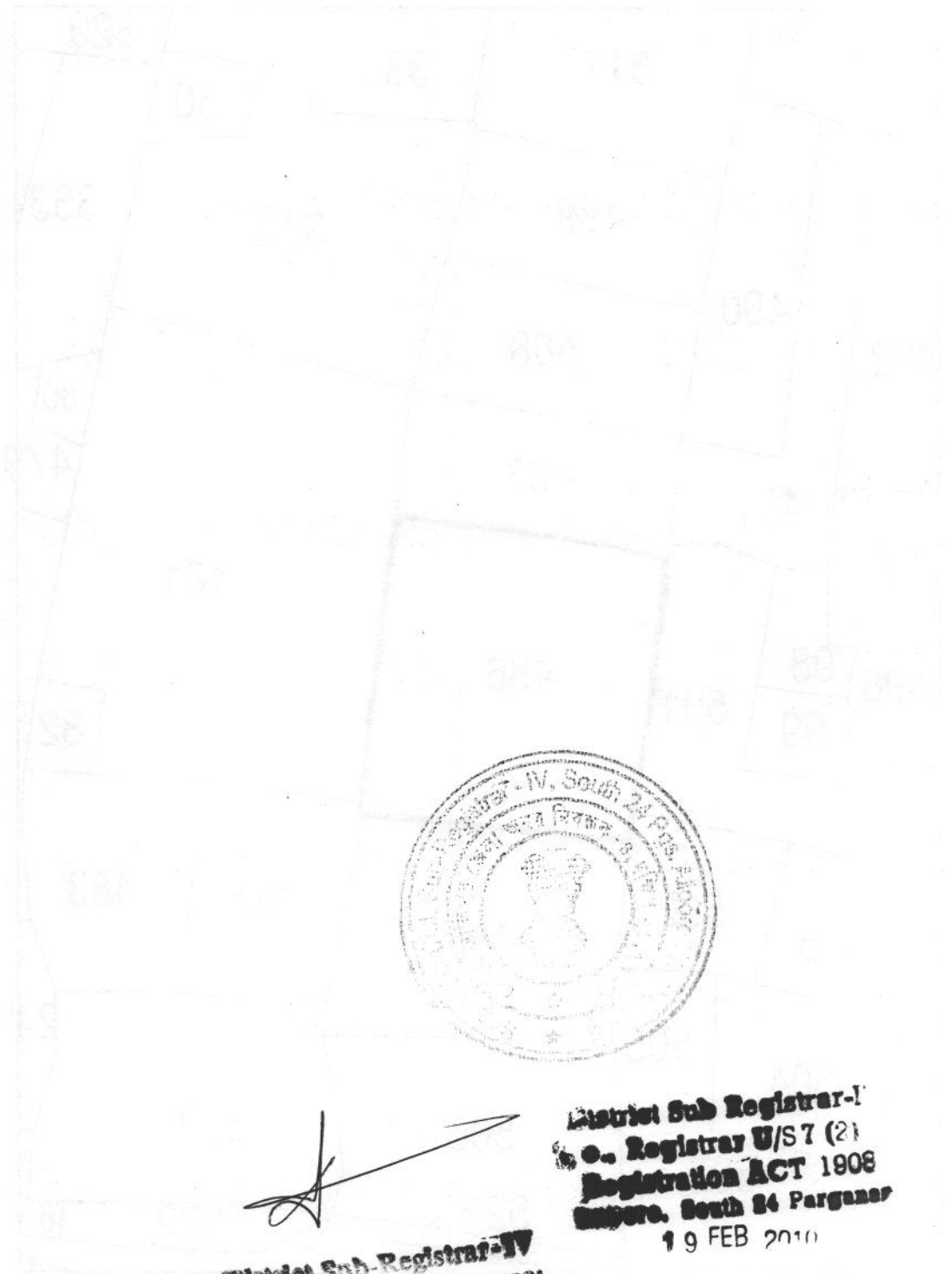
