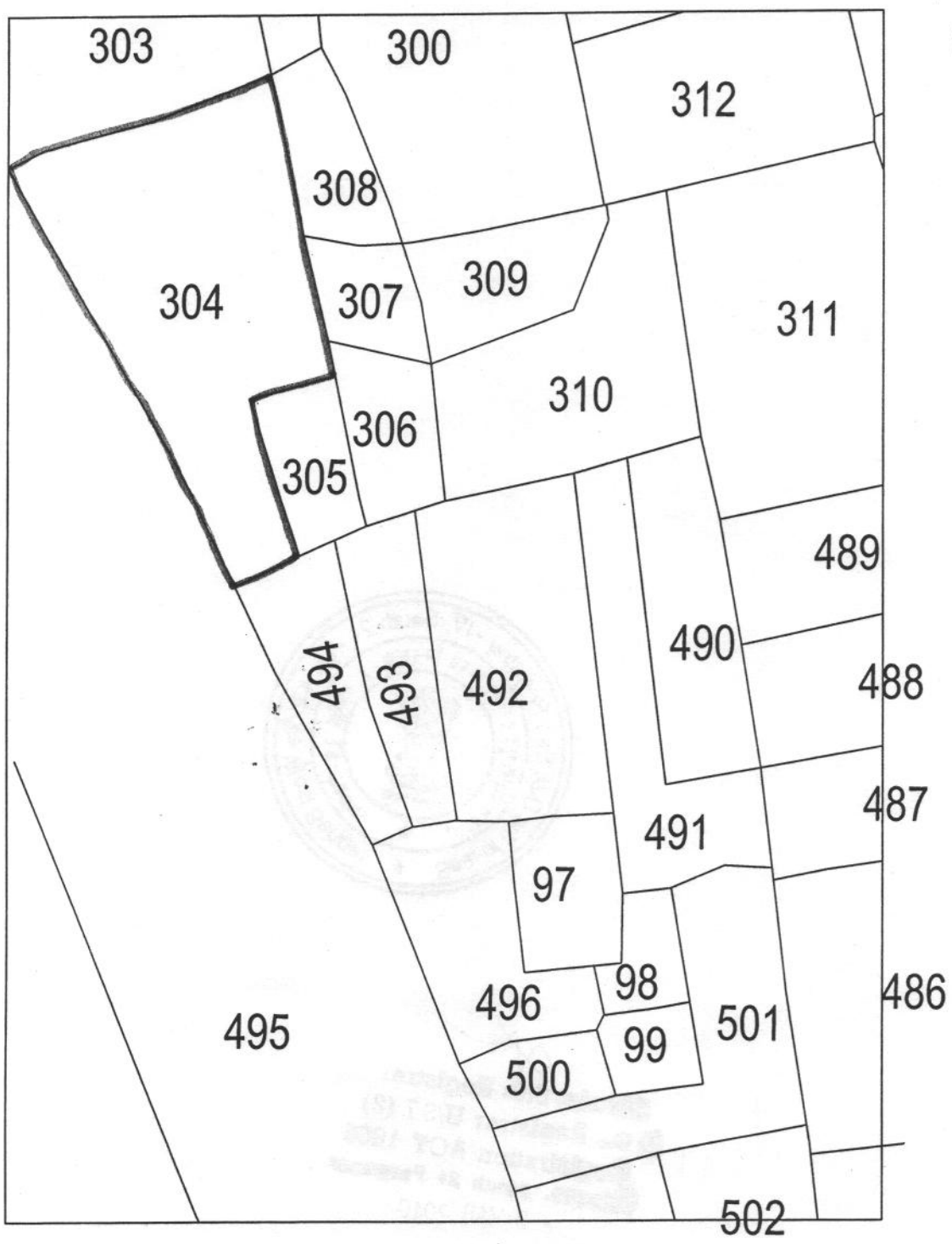

POLICE STATION -SONARPUR, DIST-24 PARGANAS(SOUTH)

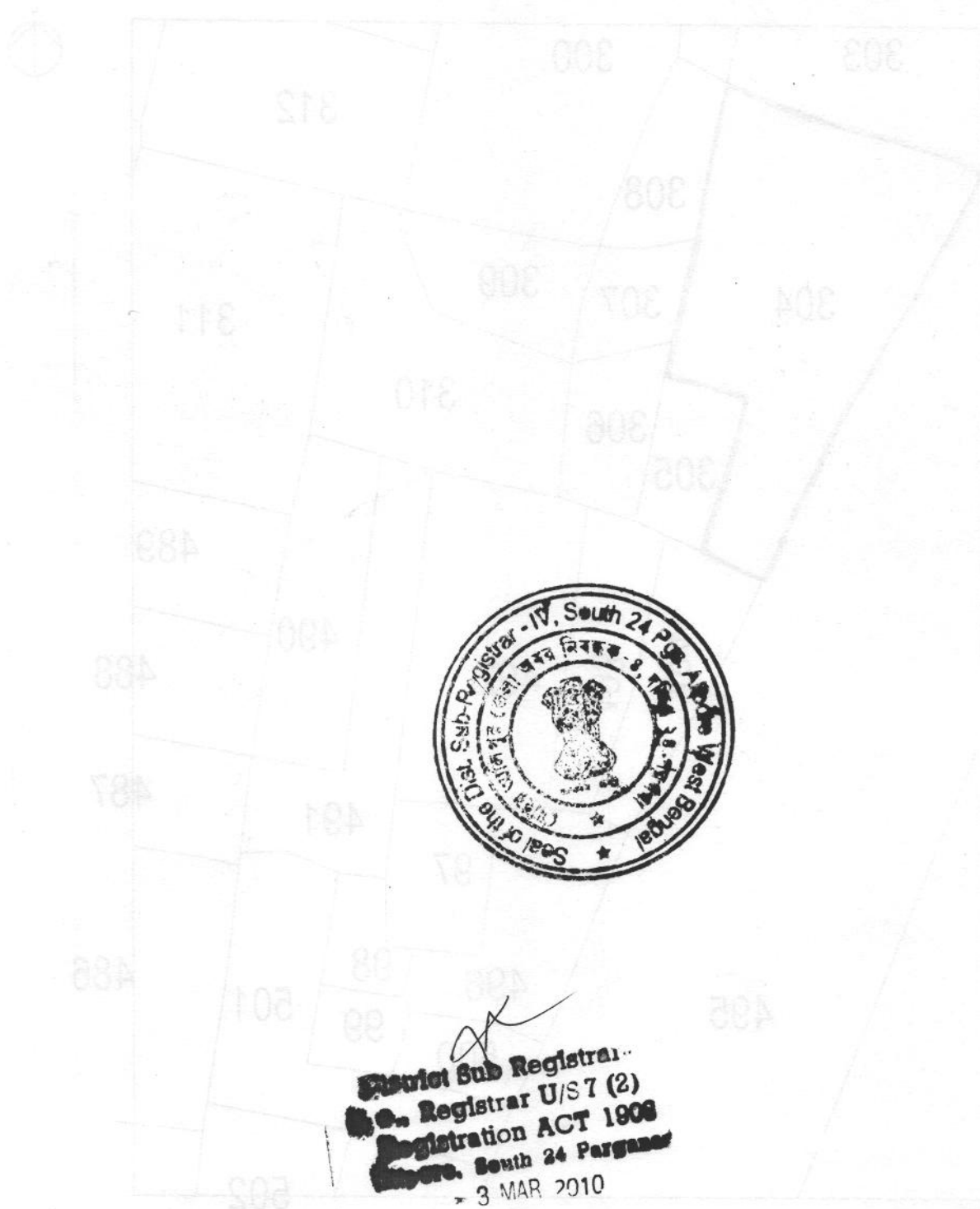

POLICE STATION SONARPUR, DIST-24 PARGANAS(SOUTH)











































