





South 24 Parganas, hereinafter referred to as the **VENDOR** (which expression shall unless excluded by or repugnant to the subject or context be deemed to mean and include her heirs, executors, administrators, legal representatives and assigns) of the **ONE PART AND AUNGKOR TRADELINK PVT. LTD**, a company incorporated under the Companies Act, 1956, having their registered office at premises No. 21 Biplabi Trailakhya Maharaj Sarani, Kolkata – 700 001, a company incorporated under the Companies Act, 1956 hereinafter referred to as the **PURCHASER** (which expression shall unless excluded by or repugnant to the subject or context be deemed to mean and include their respective successor or successors-in-interest and/or assigns) of the **OTHER PART**:

WHEREAS:

- A) One Duljan Bibi widow of The Late Chonuroddin Sheikh was the recorded owner and was seized and possessed of and/or otherwise well and sufficiently entitled to amongst others All That the piece and parcel of land containing an area of 40 Satak be the same a little more or less situate lying at Mouza Manikpur, the then P.S. Magura (now Sonarpur) Sub Registry office Sonarpur, R.S. No. 226, J.L. No. 77, Touji No. 412, Khatian No.135, Dag Nos. 496 (31 satak) and 498 (9 satak) in the District of the then 24-Parganas (now South 24 Parganas) hereinafter referred to as the "said entire land")
 - B) By a Bengali Kobala dated the 7th day of February 1964 made between the said Duljan Bibi therein referred to as the Vendor of the One Part and Radha Rani Roy therein referred to as the Purchaser of the

typographical error in the earlier Bengali Kobala dated the 11th day of 1978, wherein Dag No. 498 was erroneously mentioned as Dag No. 98.

- H) The Vendor thus became seized and possessed of and/or otherwise well and sufficiently entitled to All That the piece-and-parcel of the land containing an area of 9 satak be the same a little more or less situate lying at Mouza Manikpur, the then P.S. Magura (now Sonarpur) Sub Registry office Sonarpur, R.S. No. 226, J.L. No. 77, Touji No. 412, Khatian No.135, Dag No.498 in the District of South 24-Parganas, (hereinafter referred to as the "said land") free from all encumbrances, charges, liens, lispendens, acquisitions, requisitions, attachments, trusts of whatsoever nature.


