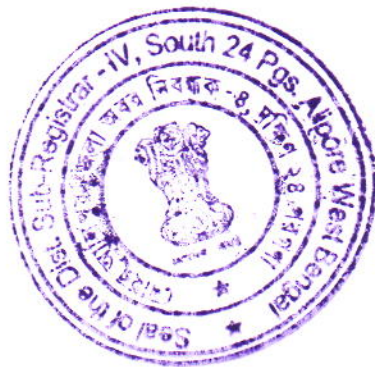
SITE PLAN IN R.S./L.R. DAG NO.483

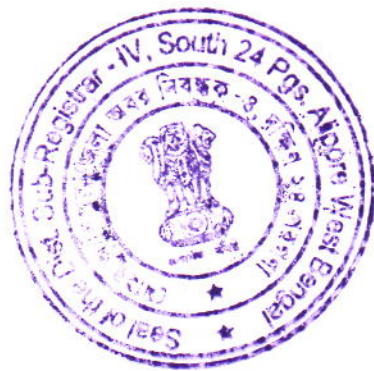
