

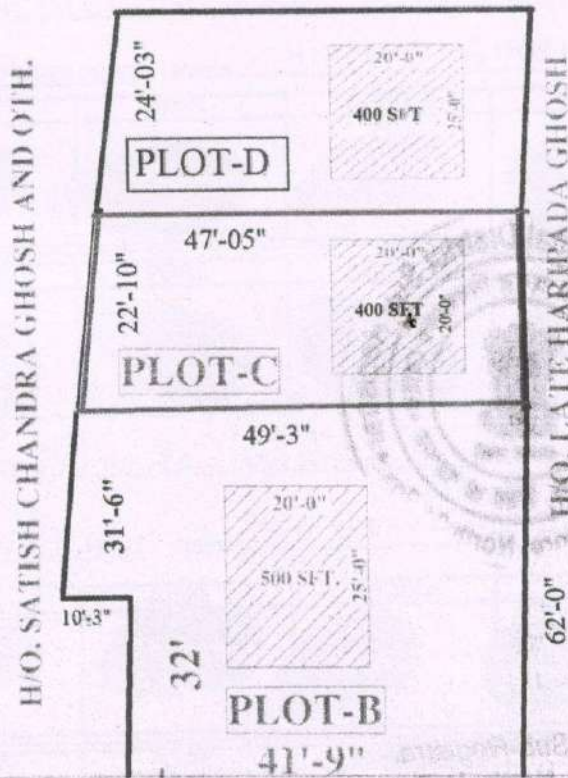
SITE PLAN ON PART OF R.S. DAG NO-1800 ,R.S.KHATIAN NO-84
