No. 1533 & No. J-11013/56/2004-IA-II(I), dated 14.09.2006, issued by the Joint Secretary to the Govt. of India, Ministry of Environment & Forests, for the proposed residential complex at Mouza: Manikpur, Holding No. 132, L.R. Khatina Nos. 1099 to 1128 and 1263 to 1348, L.R. Dag Nos. 304,305,477, 478,481 to 483, 485 to 489, 493, 496, 498 to 507, 510 to 519, 522 to 525, 535,536,539 to 542,<sup>SAS</sup>546, 573 & 574, J.L.No.-77, P.S.-Sonarpur, Dist.-24 Pgs. (S), Rajpur Sonarpur Municipality, Dist: South 24-Parganas, West Bengal, which has a distance around 2 KM away from the boundary of Chintamoni Kar Bird Sanctuary at Narendrapur and beyond the proposed Eco-Sensitive Zone of 100 mts. However, the Eco-sensitive Zone is yet to be notified.

The proposed site already has human habitations around and is unlikely to have any direct impact of the Chintamoni Kar Bird Sanctuary at Narendrapur.
