SHOWN IN RED BORDER
















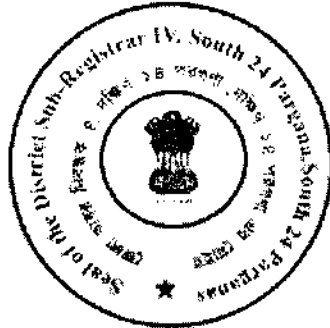
