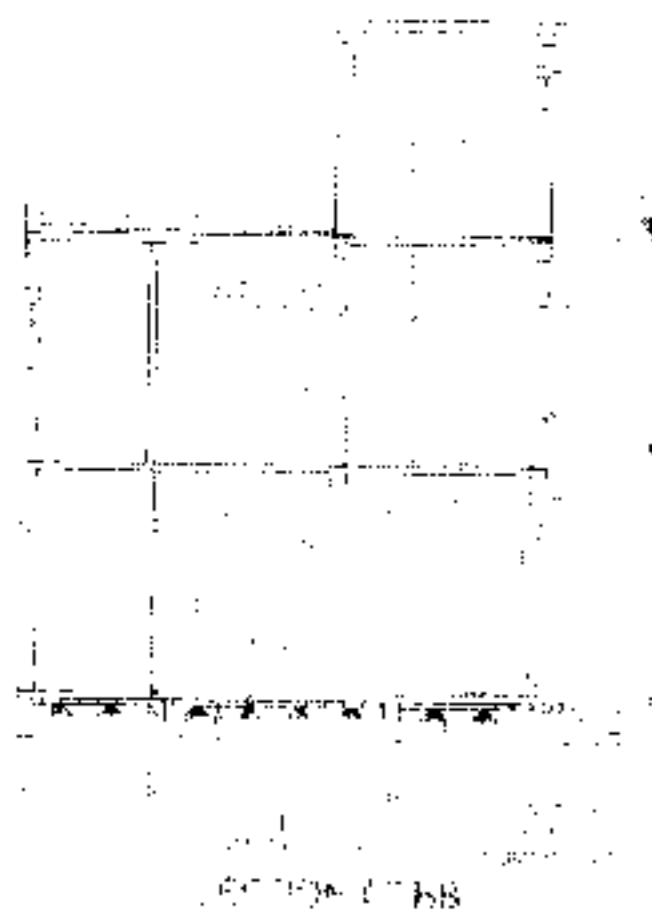
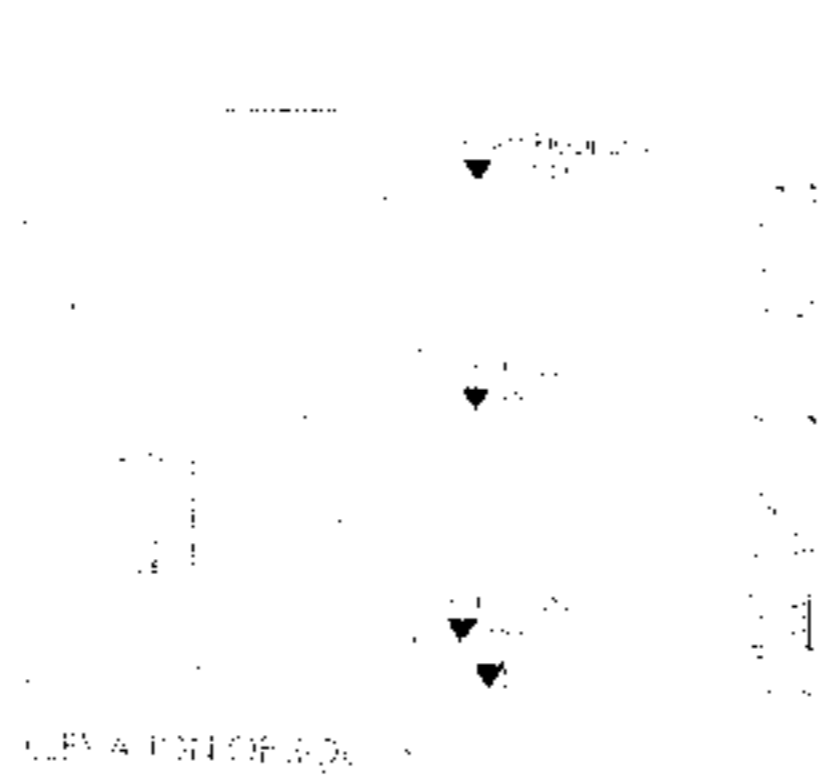


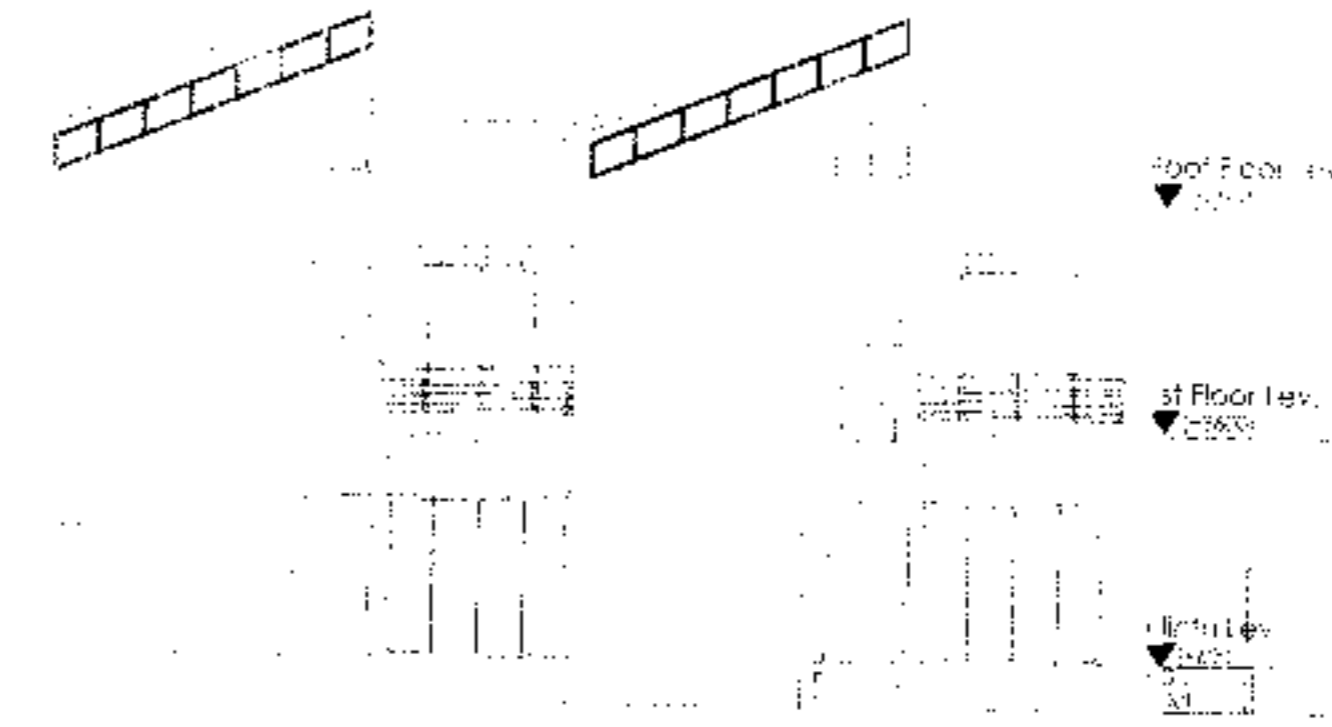

ELEVATION OF SIDE A



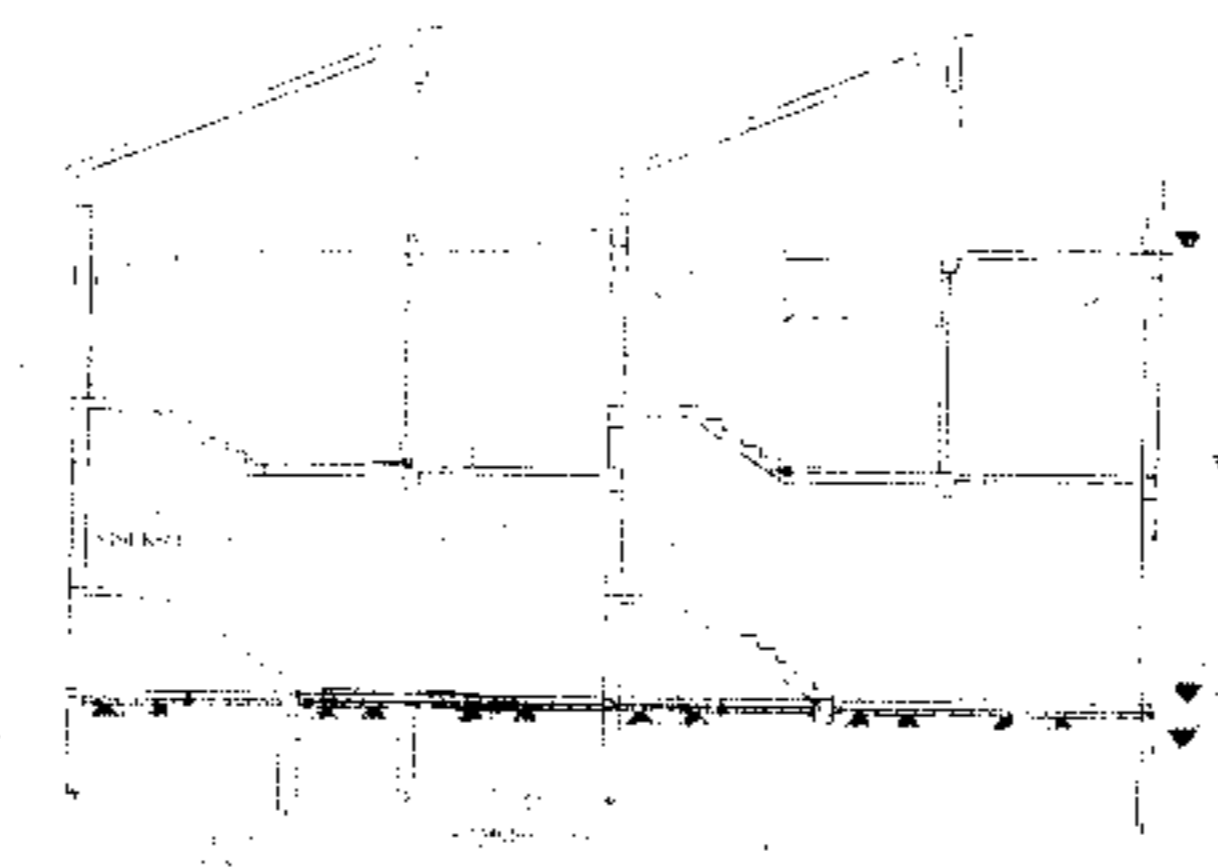
ELEVATION OF SIDE B

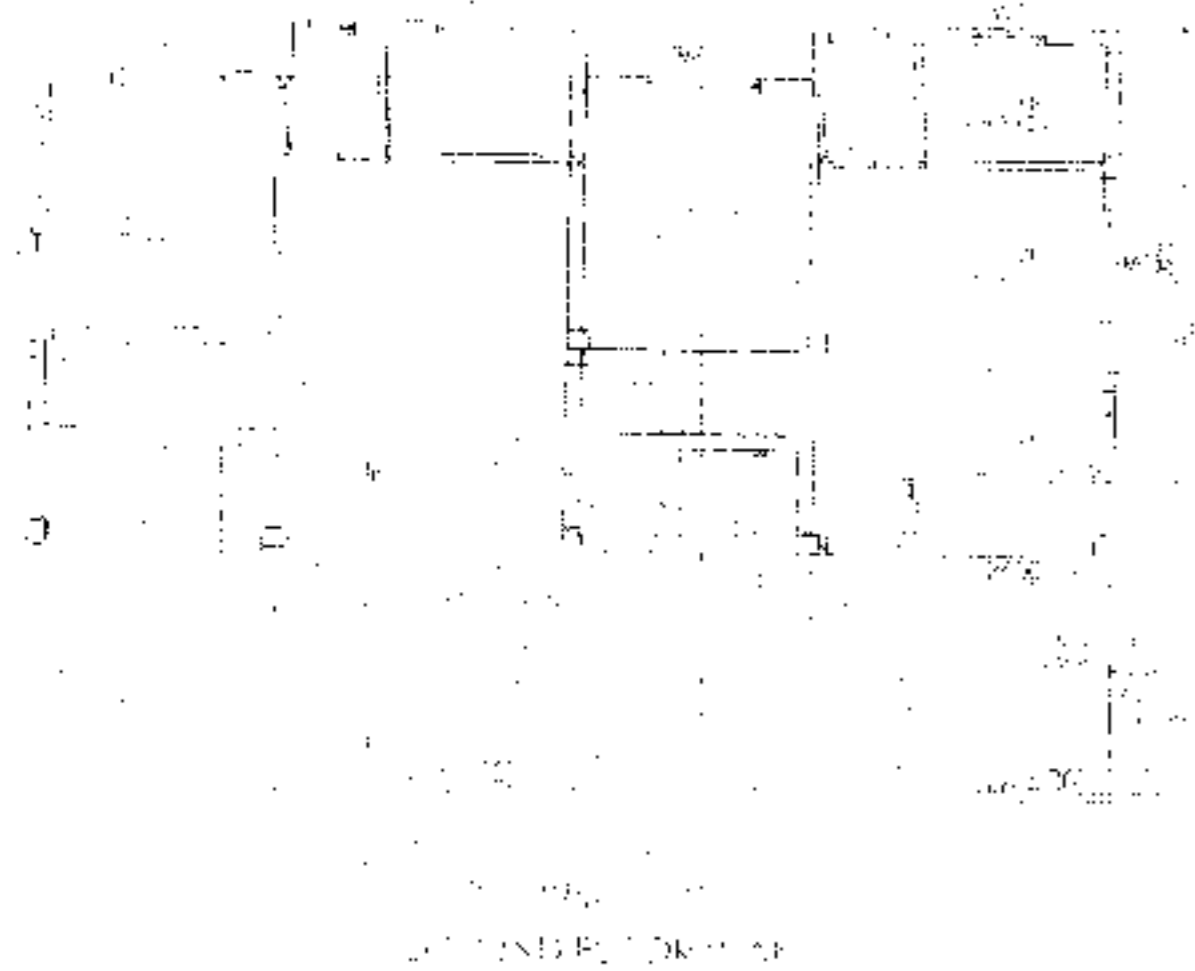
