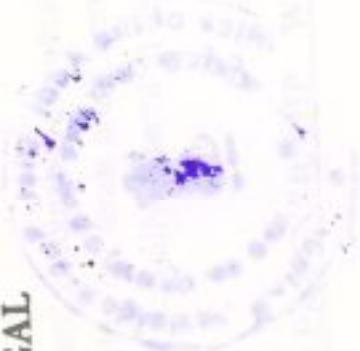

WHEREAS the parties mentioned hereinabove mutually agreed to start and carry out a business to develop the lands and Constructions and Civil Works and become partners and mutually entered in to partnership on the following terms and conditions:

**NOW THIS DEED OF PARTNERSHIP WITNESSES AS FOLLOWS:**

1. WHEREAS the parties have become and be partners in the firm of "SREE KRISHNA CONSTRUCTION CO." to carry the business to develop the lands and Constructions and Civil Works within the area of Bolpur in the District of Birbhum.
2. WHEREAS the name of the Firm shall be "SREE KRISHNA CONSTRUCTION CO." and the place of Business are ordinarily is at Bolpur within the District of Birbhum, or any place or places as the partners shall determine.
3. That the Capital of the firm shall be a sum of Rs.5,00,000/- (Rupees Five Lakhs Only) to be paid by the partners in the following ratio of shares immediately after the starting the said business:
  - a) Sri Sankar Adak to be paid 50%
  - b) Sri Dayamoy Mondal to be paid by 40%
  - c) Sri Chirabrata Mukherjee to be paid by 10%

4. That all the partners will be treated as working partners and take direct participation in the business activities as working partners.
5. That the profits and losses of the firm shall be borne by the partners in 50:40:10 ratio. The partners shall act in the said business diligently and for the greater advantage of the firm.
6. That the bankers of the said firm shall be generally State Bank of India, Bolpur Branch or the bank or banks as the partners shall mutually agreed upon.
7. That all Cheques, Bills etc. shall be deposited in the said Bank in the account of the firm and an account shall be open in the name of "SREE KRISHNA CONSTRUCTION CO." The said account shall be operated by the signatures of any two of the partners only of the firm.
8. In the event of any increase in the capital agreed upon by all the partners; such additional capital unless otherwise agreed, shall be contributed by 50:40:10 ratio of shares or that the partners shall take loan from any Bank of Banks or from any financial institutions both Government and Private or from any person or persons in the name of the firm.
9. That no partner shall sell his share in the firm to any outsider or outsiders, the first offer of Sale shall be made to other partners, and if the other partners is not willing to purchase the share of outgoing partner in writing in that case the partner can sell his share to outsider.
10. That on the death of any of the partner the firm shall not be dissolved the heirs of the deceased partner shall be the partner of the said firm and shall continue the said business with the remaining partners.
11. That the Accounting Year of the firm shall be from 1<sup>st</sup> April to 31<sup>st</sup> March respectively, in every accounting year the accounts of the said year shall be completed, the profit and losses shall be audited by an Auditor and shall be written in the Book with the signature of all partners, and all the partners shall inspect the said book with power to take copies. The profit and losses shall be divided 50:40:10 ratio amongst the partners.

12. That if there is any dispute between the partners, the partners shall mutually settle the dispute with the help of an Arbitrator, each of the partners can elect the name of one Arbitrator for his side.

13. That the firm shall be registered within six months from the date of execution of this deed of partnership before the Registrar of Firm at Kolkata.

14. That all the provisions of Indian Partnership Act and Income Tax Act, 1961 will apply in the business of the firm.
