

SEARCH REPORT

I. SECTION 'A' – DEFINITIONS:

The term used herein shall have the meaning assigned to them as follows:

(a) "Subject Property" shall mean ALL THOSE several pieces and parcels of contiguous land comprised in R.S. and L. R. Dag Nos.1061, 1062, 1063, 1064, 1065, 1067, 1074, 1076, 1077, 1078, 1079, 1080, 1083, 1084, and portions of L.R. Dag Nos.1075, 1081, 1



1082, 1085, 1086, 1087 and 1088 all recorded in L.R. Khatian No. 1208, in Mouza Kalikapur Police Station Rajarhat in the District of North 24-Parganas in the State of West Bengal.

- (b) "Crescent" shall mean CRESCENT GRIHA NIRMAN PRIVATE LIMITED, a Company incorporated under the Companies Act, 1956.
- (c) "New Buyers" shall mean the buyers listed out in Annexure 'B3" hereto under the column New Buyers.

II. SECTION 'B' - SEARCH REPORT: .

Under instructions from Mr. Pankaj Jhunjhunwala on behalf of our clients abovenamed, received in or about March, 2011 and from time to time thereafter from our abovenamed clients, necessary searches were caused to be made from time to time initially by Messrs. Pankaj Shroff & Co., Advocates and thereafter by our firm, at the named registration offices, Courts and certain other Government Departments as mentioned hereinbelow and the findings from the searches so caused to be made are as follows:

- 1. Registration Offices: Searches were from time to time caused to be made of the relevant Index II and to a certain extent, Index I at the offices of (a) the Registrar of Assurances, Kolkata/Additional Registrar of Assurances-II, Kolkata during the years 1981 till the date of searches; (b) District Registrar, Barasat during the years 1981 onwards till the date of searches; (c) Additional District Sub-Registrar, Bidhannagar, Salt Lake during the years 1984 onwards till the date of searches, (d) Additional District Sub-Registrar, Cossipore Dum Dum during the years 1981 to 1984 and (e) District Registrar, Alipore during the years 1985 to 1986. A xerox copy each of the Receipts issued by the concerned Registration Offices from time to time and the Reports of such Searches received from the searchers from time to time are annexed hereto and marked 'A1 to A1872'.
- 1.1 While causing to be made such searches at the registration offices, several entries were found. Those entries which are found relevant to the Subject Property are mentioned in Annexure "B1" hereto and those which appear to be not relevant are dealt with in Annexure "B2" hereto. In addition to those mentioned in Annexures "B1" and "B2", certain further documents were executed and registered between Crescent and some of the New Buyers particulars whereof are mentioned in Annexure "B3" hereto.
- 1.2 Certain documents were found in the recital to the chain deeds of the L.R. Recorded Raiyats but were not found in the searches. A list of such documents are mentioned in Annexure "B4" hereto.
- 1.3 We would, however, like to specifically mention the following as regards such searches

- (i) While causing to be made searches, both relevant Index-II and Index-I, for several years were found either fully or partly torn or incomplete or not available or computerized data corrupt and searches for those years could not, as such, be carried out.
- (ii) Since the time of computerization of records, the registration offices do not maintain any Indices for public inspection and the clerk sitting on the computer gives oral details to the searcher in respect of the concerned property only.
- (iii) Since the introduction of Section 47A, of Indian Stamp Act, as applicable to West Bengal, pending documents or any document which has been presented for registration, but registration whereof is kept in abeyance for want of assessment of market value by the registering authority, do not reflect in the searches and get recorded in Indices only upon payment of deficit stamp duty and registration fee applicable thereon although they take effect from the date of their execution.
- (iv) Some of the receipts/reports of searches done during 2011 were misplaced and hence the searches for the same were repeated.
- 1.4 Subject to the comments mentioned above, our searches at the registration offices as per the available records have not disclosed any encumbrance affecting the Subject Property.


2. Courts:

- 2.1 We have during the years 2011, 2012, 2014 and 2016 caused to be made necessary searches as to whether any Title Suit was filed at the Court of the 1st Civil Judge (Senior Division), Barasat or any Title Suit was filed at the Court of the 1st Civil Judge (Junior Division) at Barasat against the persons named in Annexure C hereto during the year 2000 to the respective date of issuance of the search information slips and from the information slips received by us it would appear that no Title Suit save and except one Title Suit No. 372 of 2013 (dealt below) was filed. . Xerox copies of the 236 Information Slips issued by concerned Courts are annexed hereto and marked with the letter 'C-1 to C-236'
- 2.2 The said Title Suit No. 372 of 2013 (Iman Ali Molla & Ors. -vs- Yousuf Ali Molla) was filed in the Court of 1st Civil Judge (Junior Division) Barasat, North 24 Parganas. Client has sent a copy of an information slip issued by the said Court on 29.09.2016 wherein in answer to the question whether and when the suit was withdrawn or dismissed the date has been provided as 26th September, 2016. A copy of such slip is annexed hereto and marked "C-237"
- 2.3 Besides the aforesaid Suit Crescent had instituted 4 suits for partition and other reliefs as follows.
 - 2.3.1 Title Suit No. 136 of 2012 filed before the 1st Civil Judge (Sr. Division)
 Barasat, North 24 Parganas (Crescent Griha Nirman Private Limited VSE

- Eachhia Molla and 7 Others) in respect of the said Dag No.1086. An order of status quo was passed at the instance of Crescent on 05.03.2012. The next date is fixed on 23.03.2017 for ex parte Hearing of the suit.
- 2.3.2 Title Suit No. 142 of 2012 filed before the 1st Civil Judge (Sr. Division) Barasat, North 24 Parganas (Crescent Griha Nirman Private Limited -vs- Abdur Rafique and 10 Others) in respect of the said Dag No.1087. An order of status quo was passed at the instance of Crescent on 03.03.2012. The next date is fixed on 16.03.2017 for extension of interim order and filing of Written Statement by the Defendants.
- 2.3.3 Title Suit No. 143 of 2012 filed before the 1st Civil Judge (Sr. Division) Barasat, North 24 Parganas (Crescent Griha Nirman Private Limited -vs- Yuchup Ali Molla and 5 Others) in respect of the said Dag No.1077. The said Suit was withdrawn on 12.12.2014
- 2.3.4 Title Suit No. 149 of 2012 filed before the 1st Civil Judge (Sr. Division) Barasat, North 24 Parganas (Crescent Griha Nirman Private Limited -vs- Abdul Khayer Mondal and 9 Others) in respect of Dag No.1063. The said Suit was withdrawn on 12.12,2014
- 2.4 In addition to the above we have come across one Title Suit No. 69 of 2012 filed before the 1st Civil Judge (Sr. Division) Barasat, North 24 Parganas (Abdul Rejjak Dhali & Ors. -vs- Crescent Griha Nirman Private Limited) in respect of Dag No. 1087 and other dags. The plaintiff to this Suit have since sold their part of Dag Nos. 1087 to some of the New Buyers by Deed dated 6th September 2016 mentioned in Sl. J1 of Annexure B3. Client has informed us that the Suit is proposed to be withdrawn.

3. Acquisition And Requisition Searches:

- 3.1 There appears to be no acquisition or requisition proceeding at the office of The Land Acquisition Collector, Barasat, North 24 Parganas in respect of the Dag Nos.1061, 1062, 1063, 1064, 1065, 1067, 1074, 1075, 1076, 1077, 1078, 1079, 1080, 1081, 1082, 1083, 1084, 1085, 1086, 1087 and 1088 in Mouza Kalikapur District North 24 Parganas as informed to our representative orally. An application for information was made and response has been received. A Xerox copy of the application dated 29th March, 2011 and the information given by the office of the Land Acquisition Collector North 24 Parganas vide Memo No. G/2020/LA(N)/Bst/G.Misc-1101 dated 21.06.2011 are annexed hereto and marked with the letters "D" and "D1" hereto.
- 3.2 Kolkata Metropolitan Development Authority has issued a letter No. 535KMDA/PR-416/1/(IR-1169)/2006) dated 14.09.2011 (which contains the details of the subject property and another property which was applied for separately but answered jointly) stating that there are no acquisition proceeding of the authority affecting the Subject Property. A copy of the said letter is annexed as Annexure "D2" and "D3" hereto.



4. SETTLEMENT OFFICE:

- 4.1 At the time of our causing searches in the year 2011 at the B.L.& L.R.O., L.R. Information in writing were not forthcoming and we had to rely upon the xerox records provided by the Owner and oral reports received. Subsequently, however, we obtained Computerized information in or about February-March, 2012. Client also sent to us one set of information dated 29.4.2013 and L.R. Records of Rights in favour of Crescent Griha Nirman Private Limited certified on 28th May, 2013 and computerized Records dated 04.02.2016, 09.06.2016, 16.11.2016, 21.11.2016 and 08.12.2016 in favour of the New Buyers. The information and Records are all annexed hereto and marked "E-1" to "E-101".
- 4.2 As would appear from the said information and records, the process of updation of records was in vogue at the material time and as such the areas mentioned in the information and Record of Rights had calculation errors and redundant names as well. These errors if not already corrected will need correction. A table containing the status of Dag wise mutation prepared on the basis of the said Computerized Records dated 04.02.2016, 09.06.2016 and 16.11.2016 is annexed as Annexure "E-102" to "E-116". The said table also contains error list of error found in the previous records.
- 4.3 Initially the L.R. Khatian Nos. 2858, 2859, 2860, 2861, 2862, 2863 and 2864 pertaining to Dag No. 1077 had a recorded total area of 26 satak in the name of Bosslife Enclave Private Limited, Deepshika Vincom Private Limited, Bluesnow Niketan Private Limited, Mithil Tradecom Private Limited, Subhkari Dealcom Private Limited, Brijdhara Tradecom Private Limited and Jagvandana Constructions Private Limited but in the current records dated 08.12.2016, the areas appear to have been reduced by about 4 satak owing to a claim by one Dipak Bhattacharya. Client has informed that such reduction is without the knowledge of the client and the process of challenging the same is being taken. Similar claim of the said Dipak Bhattacharya in respect of 1/7th share in 19.5 satak in Dag No. 1063 and 30 satak in Dag No. 1087 are also under objection before B.L.& L.R.O.

5. **REGISTRAR OF COMPANIES:**

As per the searches caused to be made at the site of Registrar of Companies, West Bengal, being mca.gov.in on 18th March 2011 in the name of Crescent Griha Nirman Private Limited, no charges appear to have been filed in their records. Copy of the Receipt issued by the Ministry of Corporate Affairs is annexed hereto and marked with the letter "F"

HI. <u>SECTION 'C' - STATEMENTS AND COMMENTS:</u>

Besides our statements and comments made at different places of this report, we would also like to mention the following: DSP

- (a) The report on searches is on the basis of the records available as on the date of such searches caused to be done;
- (b) Location of Property as shown in the Plan annexed to the deeds listed in Sl. Nos. R-22, R-24, R-25, R-27, R-34, R-37 and R-39 of Annexure B1 are not the same in the plan of the Subject Property as shown in the Deeds listed in Sl. Nos. A1 to A29 of Annexure B3 in respect of Dag Nos. 1081, 1082, 1085 and 1086 by Crescent.
- (c) The searches undertaken by us do not relate to any encumbrance or charge created by operation of law like statutory charges on default of payment of Income Tax, Sales Tax and other Government dues and relates to encumbrance created by those act of parties which requires, under law, a corresponding record to be maintained for the public in general at the offices at which we have caused to be made the searches as aforesaid.
- (d) The names in the L.R. Records of Rights as found initially formed the basis of searches and no prior chain of title was known or considered.
- (e) This Search Report is meant for the understanding of abovenamed Client alone and shall not be for use and reliance for any other person.

Under the circumstances as above and save and subject to what has been stated at different places hereinabove and also in the annexures hereto, our searches when made did not disclose encumbrance affecting the Subject Property.


