Dear Sir,

Please refer to the letter dated 22.02.2007 from the Vice President Shapoorji Pallonji & Co. Ltd. (SPCL) requesting to change the name of the developer from Shapoorji Pallonji & Co.Ltd. henceforth referred to as "SPCL" to Bengal Shapoorji Housing Development Pvt. Ltd. henceforth referred to as "BSHDPL".

Papers and documents furnished on behalf of Shapoorji Pallonji & Co. Ltd. reveal that

- a) M/s Melvin Investment Pvt. Ltd. one of the wholly owned subsidiary companies was changed to Bengal Shapoorji Housing Development Pvt. Ltd. (BSHDPL) and a fresh Certificate of Incorporation consequent upon change of name was issued by ROC, Maharashtra on 2nd February, 2007.
- b) As per the Board resolution of SPCL passed on 28th February, 2007 the said mass housing project on 150 acres of land would be assigned to the co's ultimate subsidiary called BSHDPL and the mother co. viz SPCL on behalf of its subsidiary (i.e. BSHDPL) will undertake to fulfill the conditions mentioned in the letter of offer of allotment dated 8th December, 2005 given by WBHIDCO Ltd. and the make such a financial arrangement as may be necessary.
- c) Shapoorji Pallonji & Co. Ltd. has also certified that the entire paid up capital for BSHDPL of Rs.35.00 lakhs is held by Sterling Investment Corporation Pvt. Ltd. which is a wholly owned subsidiary of SPCL.

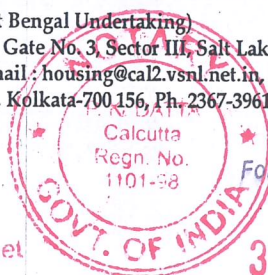
In view of the facts and circumstances as per the documents furnished, the name of the developer is now changed to "BSHDPL" being a wholly owned subsidiary of SPCL, in replacement of SPCL in respect of the development/construction of Mass Housing Project on the following conditions :-

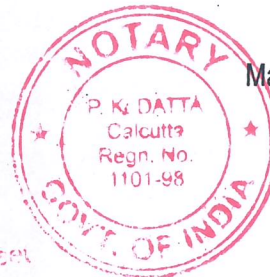
