- That I/promoter shall take all the pending approvals on time, 7. from the competent authorities.
- That I/promoter have/has furnished such other documents as 8. have been prescribed by the rules and regulations made under the Act.

That I/promoter shall not discriminate against any allottee at 9. the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
