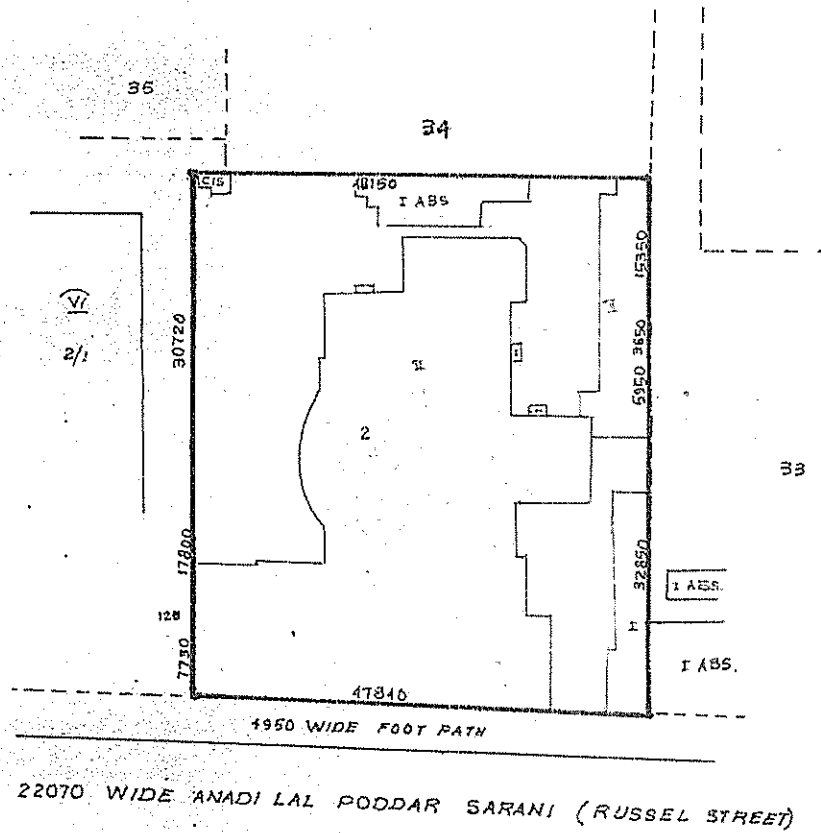








SITE PLAN AT PREMISES NO-2,

SCALE - 1:600

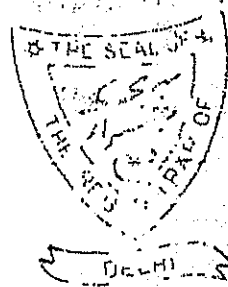
